MISSIONARIES CALLED IN THE AUGUST 1852 SPECIAL CONFERENCE



This biographical register includes everyone who was called on a mission in August 1852 or who left with that same group of missionaries. Most of the men in this register were called in August and left in the following weeks. A few missionaries were called but never served, and some of them were called in April 1852 but left with the August group months later.

Biographical entries include basic information, including full name, birth and death information, parents, and dates of key life events. Given the nature of the missionaries' callings, emphasis is given to the religious roles a person played. Many of the men found here married several women. Rather than trace their multiple marriages, the biographical entries simply state the fact of their having practiced plural marriage. Full identifying information is given for geographical places, including county information, with two exceptions: international places are most often listed without county or province, and Salt Lake City is given without full identifying information (Salt Lake Co., Utah Territory). Because of the shifting polit-

ical designation of the Latter-day Saints' new home in the Intermountain West, listings do not usually distinguish between Deseret, Utah Territory, and Utah; the term *Utah* is used throughout.

Because of space constraints, this biographical register is published without source citations. The files used to compile each biography are available in the General Epistles biographical collection at the Church History Library in Salt Lake City. Additionally, many other resources are available for further biographical research of nineteenth-century Latter-day Saints. Four important electronic resources are maintained by the Church History Department: the Joseph Smith Papers (josephsmithpapers.org/reference/people), the Early Mormon Missionaries database (history.lds.org/missionary), the Mormon Pioneer Overland Travel database (history.lds.org/overlandtravels), and the Journal of George Q. Cannon (churchhistor ianspress.org/george-q-cannon/people).

Allred, Isaac (1813–59). Born June 28, 1813, in Bedford Co., Tennessee; son of James Allred and Elizabeth Warren. Baptized in Monroe Co., Missouri, Sept. 10, 1832. Married Julia Ann Taylor in Monroe Co., Oct. 11, 1832. Participated in plural marriage. Served in Camp of Israel, 1834. Began serving mission to Missouri, Dec. 13, 1837. Began serving mission to Missouri and Kentucky, June 11, 1838. Appointed to serve mission to Missouri, ca. 1842. Appointed colonel of the fifth regiment in Nauvoo Legion, 1844. Appointed to fourth quorum of the seventy, Oct. 8, 1844. Elected constable in Kanesville (later Council Bluffs), Pottawattamie Co., Iowa, Aug. 1849. Migrated with Easton Kelsey company to the Great Salt Lake Valley, arriving Sept. 22, 1851. Served mission to England, 1852–55. Died May 11, 1859, in Mount Pleasant, Sanpete Co., Utah.

Allred, Reddin Alexander (1822–1900). Born Feb. 21, 1822, in Bedford Co., Tennessee; son of Isaac Allred and Mary Calvert; twin brother of Redick Newton Allred. Baptized by John Ivie in Missouri, spring 1833. Participated in relief expedition to rescue Joseph Smith from kidnappers, June 1843. Married Julia Ann Bates in Nauvoo, Hancock Co., Illinois, Dec. 21, 1843. Participated in plural marriage. Appointed to fourth quorum of the seventy, Oct. 8, 1844. Migrated to Great Salt Lake Valley in James W. Cummings company, arriving by Oct. 7, 1851. Served mission

to Sandwich Islands, 1852–55. Moved to St. Johns, Apache Co., Arizona Territory, by 1880. Served as justice of the peace in Graham Co., Arizona Territory. Died on June 9, 1900; buried in Thatcher, Graham Co.

Allred, Redick Newton (1822–1905). Born Feb. 21, 1822, in Farmington, Bedford Co., Tennessee; son of Isaac Allred and Mary Calvert; twin brother of Reddin Alexander Allred. Baptized in 1833 by John Ivie at Salt River, Ralls Co., Missouri, 1829. Served a mission to Indiana, 1841. Ordained a seventy in 1842. Married Lucy Hoyt, Nov. 26, 1843. Participated in plural marriage. Appointed third sergeant, company A, and staff quartermaster, Mormon Battalion, 1846-47. Migrated to the Salt Lake Valley from California with the Levi W. Hancock/Jefferson Hunt/ James Pace/Andrew Lytle company, arriving in mid-Oct. 1847. Served a mission to the Sandwich Isles, 1852-56. Participated in the rescue of the Willie and Martin handcart companies, Oct. 1856. Counselor to Bishop C. G. Larson in Spring City, Utah, about 1860. Participated in the Black Hawk War in Sanpete Co. Served five terms in the Utah territorial legislature, 1862–64, 1868, 1870. Appointed bishop of the Chester, Sanpete Co., Utah, ward, July 1877. Ordained a patriarch, May 15, 1898. Died Oct. 10, 1905, in Chester.

Atwood, Millen (1817–90). Born May 24, 1817, in Willington, Tolland Co., Connecticut; son of Dan Atwood and Polly Sawyer. Worked as a mason. Baptized in Nauvoo, Hancock Co., Illinois, Aug. 1841. Began serving mission to Wisconsin Territory, Illinois, New York, and Connecticut, July 7, 1842. Ordained a member of 10th quorum of the seventy in Nauvoo, Apr. 20, 1845. Migrated from Winter Quarters, Nebraska, to Great Salt Lake Valley with Brigham Young pioneer company, arriving July 24, 1847. Returned to Winter Quarters. Married Relief Cram in Winter Quarters, Apr. 20, 1848. Participated in plural marriage. Migrated back to Great Salt Lake Valley with Brigham Young company, arriving Sept. 19, 1848. Participated in battle against Indians in Provo, Utah Co., Utah, Feb. 1850. Ordained sixth president of 14th quorum of the seventy in Salt Lake City, by Mar. 9, 1851. Began serving mission to Europe, Sept. 16, 1852. Returned to Iowa; migrated back to Great Salt Lake Valley with James G. Willie company, arriving Nov. 9, 1856. Ordained a high priest, May 9, 1875; served

on high council. Appointed bishop of Salt Lake City 13th Ward, Dec. 25, 1881. Died on Dec. 17, 1890, in Salt Lake City.

Ballantyne, Richard (1817–98). Born Aug. 26, 1817, in Whitridgebog, Roxburgshire, Scotland; son of David Ballantyne and Ann Bannerman. Baptized by Elder Henry McCune in Edinburgh, Scotland, Oct. 30, 1842. Emigrated from Liverpool, England, to New Orleans, Louisiana, aboard the *Metoka*, arriving Oct. 27, 1843. Married Huldah Maria Clark, in Winter Quarters, Nebraska, Feb. 17, 1847. Participated in plural marriage. Migrated to the Great Salt Lake Valley in the Brigham Young company, arriving Sept. 20, 1848. Established the first Latter-day Saint Sunday School in the Salt Lake 14th Ward, 1849. Served a mission to India, 1852–54. Led pioneer company from London, England, to the Great Salt Lake Valley, arriving Sept. 25, 1855. Died in Ogden, Weber Co., Utah, Nov. 8, 1898.

Brown, Benjamin (1794-1878). Born Sept. 30, 1794, in Queensbury, Washington Co., New York; son of Asa Brown Jr. and Sarah Moon. Married Sarah Mumford, probably in Pomfret, Chautauqua Co., New York, on Sept. 2, 1819. Participated in plural marriage. Baptized in Westfield, Chautauqua Co., New York, on May 10, 1835. Ordained an elder, probably in Westfield, about 1835. Ordained a seventy in Kirtland, Geauga Co., Ohio, on Feb. 21, 1837. Served a mission in eastern New York, 1837–39. Served a mission in eastern New York and Vermont, 1841. Ordained a high priest in Nauvoo, Hancock Co., Illinois, on July 23, 1843. Served a mission in Cook Co., Illinois; Jefferson Co., New York; and the provinces of Nova Scotia and New Brunswick, Canada, 1843–44. Sent on a tithing mission to Jefferson Co., 1845. Called as a bishop in Winter Quarters, 1846. Emigrated with the Brigham Young company, arriving in the Salt Lake Valley on Sept. 21, 1848. Served as bishop of the Salt Lake Fourth Ward, 1849-66. Served in the British Mission, 1853-55. Served in the pastoral charge of the London, Reading, Kent, and Essex conferences, 1853-54. Ordained a patriarch in Salt Lake City on May 7, 1873. Died in Salt Lake City, May 22, 1878.

Brown, James (1801–63). Born Sept. 30, 1801, in Flat Swamp Creek, Rowan Co., North Carolina; son of James Brown and Mary (Polly) Wil-

liams. Married Martha Stephens in Flat Swamp Creek, Mar. 2, 1823. Participated in plural marriage. Moved to Brown Co., Illinois, in 1833, then to Adams Co., Illinois, in 1835, where he served as justice of the peace. Baptized in June 1839 in Adams Co. Served missions to Alabama in 1843, Iowa Territory in 1844, and North Carolina. Served as captain of Company C in the Mormon Battalion. Arrived in Salt Lake City on July 29, 1847. Founded Brownsville, later renamed Ogden, Jan. 1848. Served as bishop of Brownsville, starting in Feb. 1849. Served a mission to British Guiana, 1852–53. Served as an agent for the church in New Orleans, Louisiana, assisting immigrants with transportation to Missouri, 1854. Served as counselor in the stake presidency in Weber Co. Died Sept. 30, 1863, in Ogden, Utah.

Brown, John (1820-96). Born Oct. 23, 1820, near Castalian Springs, Sumner Co., Tennessee; son of John Brown and Martha Chapman. Moved to Perry Co., Illinois, in 1829, where he taught school. Baptized in Perry Co., July 1841. Moved to Nauvoo, Hancock Co., Illinois, Oct. 1841. Ordained an elder by Hyrum Smith, Feb. 9, 1842. Served a mission in southern Illinois, Jan.-Apr. 1843, and in the southern states, May 1843-45. Married Elizabeth Crosby in Monroe Co., Mississippi, May 21, 1844. Ordained a seventy on Nov. 12, 1844, in Monroe Co. Helped lead the Mississippi company from Monroe Co. to Pueblo, Colorado, Apr.-Aug. 1846. Migrated with Brigham Young pioneer company as captain of ten, arriving July 22, 1847. Appointed captain of the company of men (including members of the Mormon Battalion) returning to the United States, Aug. 30, 1847. Returned to Tennessee, winter 1848. With other southern Saints, moved to Winter Quarters in spring 1848. Migrated with Willard Richards company as captain of ten, arriving in the Salt Lake Valley Oct. 16, 1848. Appointed captain of fifty in the Parley P. Pratt company to explore southern Utah, Nov. 23, 1849. Elected to the Utah territorial legislature from Salt Lake Co., Dec. 1851. Ordained president of the eighth quorum of the seventy, Apr. 9, 1852. Captain of exploratory party to southern Utah, June 2, 1852; appointed captain of the company. Elected a representative for Utah and Cedar counties to the territorial legislature, Aug. 1859. Served a mission to England, 1860–62. Ordained bishop of Pleasant Grove Ward, Utah Co., Feb. 2, 1863; served twenty-eight years. Elected mayor of Pleasant Grove, Feb. 9, 1863; served twenty years. Presided over the Southern States Mission, 1867–68. Ordained a patriarch in Kanab, Kane Co., Utah, Sept. 1, 1893. Died Nov. 4, 1896, in Pleasant Grove.

Buckland, Alondus De Lafayette (1823–54). Born Dec. 11, 1823, in Tunbridge, Windsor Co., Vermont; son of Joseph Mosely Buckland and Hannah Daggett. Baptized Dec. 22, 1845. Sailed on the ship *Brooklyn* with Sam Brannan, arriving in Yerba Buena (now San Francisco), California, July 31, 1846. Married Nancy Laura Aldrich in Yerba Buena, Oct. 10, 1846. Participated in plural marriage. Lived in San Francisco, Stanislaus, and Stockton, California, 1847–49. Emigrated with the Thomas Rhoades gold train, arriving in Salt Lake Valley, Oct. 1849. Living in Davis Co., Utah, 1850–52. Served a mission to Nova Scotia and the British provinces, 1852–54. Arrived at Fort Leavenworth, Kansas, May 11, 1854. Died of cholera near Fort Leavenworth, June 22, 1854.

Edward Bunker (1822-1901). Born Aug. 1, 1822, in Atkinson, Penobscot (now Piscataquis) Co., Maine; son of Silas Bunker and Hannah Berry. Farmer, road builder, and laborer. Baptized Apr. 1845 in Cleveland, Cuyahoga Co., Ohio. Moved to Nauvoo, Hancock Co., Illinois, July 1845. Married Emily Abbott, Feb. 9, 1846, in Nauvoo. Joined the Mormon Battalion. Discharged July 16, 1847, in Los Angeles, California Territory. Rejoined his wife in Winter Quarters, present-day Douglas Co., Nebraska, 1847. Migrated to Salt Lake Valley, Utah Territory, and arrived Sept. 1, 1850. Moved to Ogden, Weber Co., Utah. Participated in plural marriage. Appointed to serve a mission to England, Aug. 28, 1852. Arrived in England, Jan. 5, 1853. Served two years as the District President of the Bristol, Sheffield, Bradford, and Lincolnshire conferences in England, then appointed to preside over the Dundee, Glasgow, and Edinburgh conferences in Scotland for another year. Released from his mission Dec. 8, 1855. Captain of the Edward Bunker company consisting of mostly Welsh Saints that started in Iowa City (outfitting post), Johnson Co., Iowa, traveled to Florence, Douglas Co., Nebraska, and arrived in Salt Lake City on Oct. 2, 1856. Appointed bishop of the Ogden Second Ward, Ogden, Weber Co., Utah. Appointed to serve in the southern Utah cotton mission at the Oct. 1861 general conference. Appointed to preside over and be bishop of the members who located in Santa Clara, Washington Co., Utah, fall 1862. Participated in the United Order. Jan. 1, 1877, formed a temporary organization of member families to move to Mesquite (renamed Bunkerville), Nevada. Ordained a patriarch Sept. 10, 1900. Moved to Mexico, 1901. Died Nov. 17, 1901, in Colonia Morelos, Sonora, Mexico.

Burgess, William, Jr. (1822–1904). Born Mar. 1, 1822, in Putnam, Washington Co., New York; son of William Burgess and Vilate Stockwell. Served as a captain and a colonel in the Black Hawk War in 1832. Baptized Jan. 8, 1835, in Kirtland, Ohio. Married Maria Pulsipher in Lima, Adams Co., Illinois, Sept. 17, 1840. Participated in plural marriage. Served in the Nauvoo Legion in 1841, captain of the third company, fifth regiment, eighth brigade. Ordained to second quorum of the seventy, Oct. 8, 1844. Emigrated in the Brigham Young company of 1848, arriving in Salt Lake Valley by Sept. 24, 1848. Living in Salt Lake City, 1850 and 1860. Called on a mission to England, Aug. 1852; to the Indians at Fort Limhi, Oregon, 1855–56. Moved to St. George, Washington Co., Utah, in 1862, living the during the winters and in Pine Valley, Washington Co., Utah, during the summers until 1880. Moved to Huntington, Emery Co., Utah, in 1886. Died Mar. 14, 1904, in Huntington.

Camp, Williams Washington (1800–75). Born Dec. 11, 1800, in Warren Co., Georgia; son of Cecil (Cecillus) Camp and Mary or Margaret Williams. Married Diannah Greer, about 1821, in Tuscaloosa Co., Alabama. Participated in plural marriage. Baptized in 1842 in Tennessee. Migrated to the Salt Lake Valley in the Shadrach Roundy company, arriving Sept. 1850. Brought slaves with him to Utah. Ordained a high priest on May 29, 1852, in Salt Lake City. Selected and set apart to serve a mission to Texas, Aug. 1852. Served a mission to Las Vegas in 1856. Lived in Salt Lake Co., Utah, 1860–75. Died Nov. 21, 1875, in Salt Lake City.

Carter, William Furlsbury (1811–88). Born May 1, 1811, in Newry, Oxford Co., Maine; son of John Carter and Hannah Knight Libby. Married Sarah York in 1831 in Bethel, Oxford Co. Participated in plural marriage. Baptized Nov. 17, 1834, by Daniel Bean in Newry. Ordained an elder in 1836 in Kirtland, Geauga Co., Ohio. Ordained a seventy, Apr. 9, 1838,

in Far West, Caldwell Co., Missouri. Served as drum major in the third regiment, second cohort, Nauvoo Legion, 1841. Ordained a president of the seventy in Nauvoo, Hancock Co., Illinois, Jan. 24, 1843. Ordained one of the seven presidents of the 20th quorum of the seventy, Mar. 18, 1845, in Morleysville, Hancock Co. Served a mission to India, 1852–54. Ordained a high priest, June 1856, in Provo, Utah Co., Utah. Served in the Black Hawk War, May 11–Aug. 29, 1866. Died in Santaquin, Utah Co., Oct. 11, 1888.

Clayton, William (1814–79). Born July 17, 1814, in Charnock Moss, Lancastershire, England; son of Thomas Clayton and Ann Critchley. Married Ruth Moon, Oct. 9, 1836, in Eccleston Parish, Lancastershire. Participated in plural marriage. Baptized by Heber C. Kimball in the River Ribble, near Preston, England, on Oct. 21, 1837. Served as clerk to Heber C. Kimball in 1840. Emigrated on the *North America*, sailing from Liverpool, England, to New York, arriving on Oct. 12, 1840. Arrived in Nauvoo, Hancock Co., Illinois, on Nov. 24, 1840. Member of the high priest quorum in Nauvoo, Apr. 7, 1841. Appointed to the high council of Nauvoo, Apr. 24, 1841. Served as clerk to Joseph Smith, 1842. Served as recorder for the Nauvoo Temple, 1842. Served as treasurer of Nauvoo, 1842. Emigrated with the Brigham Young pioneer company, arriving in Salt Lake Valley in July 1847. Served a mission to England, 1852–53. Served as auditor in Salt Lake Territory, 1870. Died in Salt Lake City on Dec. 4, 1879.

Cluff (Clough), Moses C. (1828–1903). Born Feb. 20, 1828, in Durham, Strafford Co., New Hampshire; son of David Cluff Sr. and Elizabeth (Betsy) Hall. Baptized about 1836 in New Hampshire. Moved to Nauvoo, Hancock Co., Illinois, in 1840. Migrated to the Great Salt Lake Valley, probably working as a teamster for Seth M. Blair company, arriving Sept. 7, 1850. Lived in Utah Co., Utah, in 1850. Called to serve mission to Berlin, Prussia, but was detained in England, lacking a passport. Served a mission to England, 1853–56. Appointed president of the Newcastle upon Tyne conference about 1855. Appointed to the presidency of the Cambridgeshire conference, 1855. Assigned to lead "church herd" of cattle to Utah behind the William B. Hodgetts company, 1856. Married Rebecca Langman, Dec. 25, 1856. Participated in plural marriage. Delivered mail

between Provo and Heber City while living in Provo, Utah Co., Utah. Moved to Apache Co., Arizona, by 1880. Died Jan. 30, 1903, in Pima, Graham Co., Arizona.

Cook, Richard (1822-74). Born Dec. 10, 1822, in Cranwell, Lincolnshire, England; son of John Cook and Charlotte Waddington. Baptized 1840 or Sept. 1841. Married Ellen Haworth on Aug. 13, 1848, in Radcliffe, Lancashire, England. Participated in plural marriage. Emigrated from England and arrived in New Orleans, Louisiana, Mar. 11, 1850. Migrated from Kanesville (now Council Bluffs), Iowa Territory, with the Milo Andrus company, arriving in Salt Lake City on Aug. 30, 1850. Appointed to serve a mission to England, Aug. 1852. Served as president of the group of emigrating church members who sailed from Liverpool, England, on the ship *Germanicus* on Apr. 4, 1854, and arrived in New Orleans on June 13, 1854. Appointed first counselor of the Robert L. Campbell company that arrived in Salt Lake City, Oct. 1854. Appointed bishop of the South Weber Ward, Davis Co., Utah, 1857–61. Joined the Church of Jesus Christ of Saints of the Most High (Morrisites) in 1861; appointed first counselor to Joseph Morris. Died on May 23, 1874, in Douglas Co., Nevada.

Crandall, Spicer Wells (1822–79). Born Dec. 31, 1822, probably in York, Genesee Co., New York; son of Daniel Crandall and Margaret Mc-Bride. Baptized Mar. 15, 1837, in York, Pike Co., Missouri. Married Sarah Gill in Hancock Co., Illinois, Oct. 15, 1843. Living in Nauvoo, 1846. Wife died; married Irinda Spafford in Macedonia, Pottawattamie Co., Iowa, Oct. 1, 1849. Migrated with the Warren Foote company, arriving in the Salt Lake Valley in late Sept., 1850. Wife died from cholera on the trek; married Sophia Kellogg in Springville, Utah Co., Utah, by Dec. 5, 1850. Served a mission to England, 1852–56. Assisted the Daniel D. McArthur handcart company from Iowa City, Iowa, arriving in the Salt Lake Valley, Sept. 26, 1856. Living in Springville, 1860. Served as member of the Springville city council, 1857–59, counselor to Mayor Lorenzo Johnson, 1858–1861. Died in Springville on May 14, 1879.

Daniels, Daniel (1807–79). Born Aug. 9, 1807, in Llain, Llapumsaint, South Wales; son of David Daniels and Dinah Davies. Baptized Oct. 7,

1847. Married Mary Jeremy about 1829 in Carmarthenshire, South Wales. Emigrated from Wales, sailing aboard the *Buena Vista* from Liverpool, England, to New Orleans, Louisiana, arriving on Mar. 19, 1849. Migrated to the Salt Lake Valley as captain of ten with the George A. Smith/Dan Jones company, arriving in late Oct. 1849. Served a mission to Wales, 1852–56. Ordained a high priest, Jan. 22, 1851. Counselor to Thomas Jeremy, branch president of Welsh branch. Served as president of Malad, Oneida Co., Idaho, 1874; bishop of Malad Ward, before 1877. Died Sept. 1, 1879, in Malad.

Deuel, Osmyn Merrit (1802–89). Born Jan. 1, 1802, in Galway, Saratoga Co., New York; son of Lewis Deuel and Mary Barton. Married Mary Whiting by 1830. Participated in plural marriage. Member of the Nauvoo Legion. Ordained an elder in Kirtland, Geauga (Lake) Co., Ohio, on Mar. 17, 1836. Served a mission to New York to promote Joseph Smith's candidacy as president of the United States, 1844. Emigrated with the Charles C. Rich company, arriving in the Salt Lake Valley on Oct. 2, 1847. Second counselor of the North Canyon Ward, 1849–51. Served in the British Mission, 1853–55. President of the Staffordshire Conference, 1854. Captain of ten for the Jacob F. Secrist/Noah T. Guymon company, 1855. Died in Centerville, Davis Co., Utah Territory, on Jan. 11, 1889.

Dewey, Benjamin Franklin (1829–1904). Born May 5, 1829, in Westfield, Hamden Co., Massachusetts; son of Ashbel Dewey and Harriet Adams. Baptized in Winter Quarters by Wilford Woodruff, 1847. Emigrated with the Brigham Young pioneer company, arriving in the Salt Lake Valley in July 1847. Living in Greenwood Valley, California, May 1850. Living in Salt Lake City, Sept. 1850. Ordained a seventy, Oct. 10, 1852. Served a mission in India, Sri Lanka, and Hong Kong, 1852–54. Helped colonize San Bernardino, California, 1855. Married Alzira Smithson in San Bernardino Co., May 9, 1855. Living in Salt Lake Eighth Ward, 1860–80. Living in Indian Secret Mining District, Mohave Co., Arizona Territory, 1900. Died in Chloride, Mohave Co., Feb. 23, 1904.

Dowdle, Absalom Porter (1819–97). Born June 1, 1819, in Franklin Co., Alabama; son of Robert Dowdle and Sarah Ann Robinson. Baptized

Oct. 18, 1844, in Franklin Co., Alabama. Ordained a missionary in Oct. 1844 in Alabama. Married Sarah Ann Holladay in Marion Co., Alabama, ca. 1845. Participated in plural marriage. Traveled to Fort Pueblo, Colorado, in 1846. Presided at Fort Pueblo. Migrated with the Mississippi company arriving in Salt Lake Valley in July 1847. Served a mission to Australia, 1852–57. Presided over mission, 1856–57. Lived in Coalville, Summit Co., Utah, 1857–60. Lived in Provo, Utah Co., Utah, 1860–68. Died in Weber Co., Utah, on June 5, 1897.

Duncan, Chapman (1812–1900). Born July 1, 1812, in Barnet, Caledonia Co., Vermont, or Bath, Grafton Co., New Hampshire; son of John Duncan and Betsy Taylor Putnam. Baptized in Jackson Co., Missouri, Dec. 1832. Married Rebecca Rose, May 1835. Participated in plural marriage. Appointed to serve mission to Virginia, Apr. 1844. Earl, Sylvester Henry (1815–73). Born Aug. 16, 1815, in Scioto Co., Ohio; son of Joseph Earl II and Dorcas Tabitha Wixom. Baptized Feb. 29, 1837. Ordained an elder, Nov. 1837, in Far West, Missouri. Married Lois Caroline Owen, Jan. 28, 1839. Participated in plural marriage. Served a mission in Indiana and Ohio, 1841–42. Ordained a seventy, 1844. Emigrated to the Salt Lake Valley in Brigham Young's pioneer company, arriving in late July 1847. Served a mission to England, 1852–55. Ordained a high priest, May 6, 1856. Living in Pine Valley, Washington Co., Utah, 1870. Died in Middleton, Washington Co., July 23, 1873.

Eldredge, Horace Sunderlin (1816–88). Born Feb. 6, 1816, in Brutus, Cayuga Co., New York; son of Alanson Eldredge and Esther Sunderlin. Baptized June 4, 1836, in New York. Married Betsy Ann Chase in Buffalo, Erie Co., New York, on July 20, 1836. Participated in plural marriage. Moved to Nauvoo, Hancock Co., Illinois, in 1840. Ordained a seventy in 1844. Served as president of the 13th quorum of the seventy in Nauvoo, Dec. 22, 1844. Migrated with the Brigham Young company as company

marshal, arriving in the Salt Lake Valley in Sept. 1848. Appointed marshal of the territorial militia, 1848. Served as president of the St. Louis, Missouri, conference and general church agent of emigration and purchasing, 1852–54. Served as a member of the territorial legislature, 1854–62. Served as church emigration agent at New York, 1862–64. Served as mission president of the European mission, 1870–71. Died in Salt Lake City, Sept. 6, 1888.

Eldredge, John Sunderlin (1821–71). Born Apr. 30, 1821, in Brutus, Cayuga, New York; son of Alanson Eldredge and Esther Sunderlin. Baptized in June 1843. Emigrated with the Brigham Young pioneer company, arriving in the Salt Lake Valley by July 24, 1847. Married Sinah Ceneth Chipman in Salt Lake Valley, Mar. 24, 1849. Participated in plural marriage. Served as a president of the 13th quorum of the seventy. Clerk of the American Fork, Utah Co., Utah, branch, 1851. Served as choir director of the American Fork Branch. Served a mission to Australia, 1852–55. Set apart to administer to the sick in the American Fork Branch, Oct. 26, 1856. Died in Charleston, Wasatch Co., Utah, May 5, 1871; buried in American Fork.

Empey, William Adam (1808–90). Born July 4, 1808, in Osnabruck, Canada; son of Adam Empey and Margaret Van Steenbergh. Baptized in Jan. 1839. Married Mary Ann Morgan on Sept. 16, 1829. Practiced plural marriage. Member of the 13th quorum of the seventy, July 4, 1844. Migrated to the Salt Lake Valley with the Brigham Young pioneer company. Assigned by Brigham Young to build the first ferry across the Platte River, 1847. Bishopric member in the 15th Ward, Salt Lake City. Served a mission to England, 1852–54. Called to strengthen the settlements in southern Utah. Died Aug. 19, 1890, in St. George, Washington Co., Utah.

Farnham (Farnum), Augustus Alvin (Alwin) (1805–65). Born May 20, 1805, in Andover, Essex Co., Massachusetts; son of Peter Farnum and Chloe Wilson. Married Mary Jane Pottle in Boston, Suffolk Co., Massachusetts, July 5, 1840. Participated in plural marriage. Moved to Morgan City, Morgan Co., Illinois, by Apr. 6, 1842. Baptized Apr. 21, 1843, probably in Illinois. Served as first lieutenant with the Illinois state militia, by July

19, 1843. Did carpentry work on the Nauvoo temple, 1843–45. Ordained a seventy by Oct. 8, 1844; member of the sixth quorum of the seventy in Nauvoo, Hancock Co., Illinois. Served as president of the 29th quorum of the seventy in Nauvoo, 1845. Moved to St. Louis, St. Louis Co., Missouri, by June 27, 1847. Counselor to Bishop Nathaniel Henry Felt in St. Louis, 1849. Migrated to Utah with the Silas Richards company, arriving in Oct. 1849. Served a mission to Australia, 1852–56. Served as mission president in Australia, 1853–56. One of the first missionaries to New Zealand, arriving in Auckland on Oct. 27, 1855. Left Australia May 27, 1856, with 125 converts. Returned to Utah on Nov. 21, 1856. Designed tabernacle in Bountiful, Davis Co., Utah, 1857. Died May 2, 1865, in Farmington, Davis Co., Utah. Buried in Salt Lake City.

Farr, Aaron Freeman (1818–1903). Born Oct. 31, 1818, in Waterford, Caledonia Co., Vermont; son of Winslow Farr Sr. and Olive Hovey Freeman. Baptized May 19, 1832, in Vermont. Moved to Kirtland, Geauga Co., Ohio, in 1836; to Far West, Caldwell Co., Missouri, in 1838; and to Nauvoo, Hancock Co., Illinois, in 1842. Married Persis Atherton in Nauvoo, Jan. 15, 1844. Participated in plural marriage. Served mission to Indiana in 1844. Ordained a high priest in Nauvoo, Dec. 15, 1844. Migrated with the Brigham Young pioneer company, arriving in the Salt Lake Valley in July 1847. Served a mission to the West Indies and northern states, 1852–53. Presided over the St. Louis, Missouri, conference, 1854. Served as probate judge of Weber Co., Utah, 1859–69. Served a mission to the eastern states, Oct. 1869–Mar. 1870. Lived in Ogden, Weber Co., Utah, 1870–1903. Died in Logan, Cache Co., Utah, Nov. 18, 1903.

Fleming, Josiah Wolcott (1808–73). Born Apr. 25, 1808, in Middleton, Harrison Co., Virginia (now West Virginia); son of William Fleming and Ann (Nancy) Fleming. Married Nancy Bigler in Harrison Co., Virginia, June 3, 1828. Participated in plural marriage. Living in Harrison Co., Virginia, in 1830. Baptized in the North Fork River in Virginia by Jedediah M. Grant, Oct. 1837. Lived in Far West, Caldwell Co., Missouri. Living in Nauvoo, Hancock Co., Illinois, by 1840. Ordained a high priest, Oct. 6, 1843. Migrated in June 1850, possibly with the James Lake company that arrived in the Salt Lake Valley in early Sept. 1850. Living in Salt

Lake City by 1851. Served a mission to Australia, 1852–56; called as counselor to Augustus Farnham, Jan. 7, 1855. Served as a second lieutenant during the Black Hawk War, enlisting Oct. 3, 1865. Died Jan. 6, 1873, in Provo, Utah Co., Utah.

Fotheringham, William (1826–1913). Born Apr. 6, 1826, in Clackmannan, Scotland; son of John Fotheringham and Charlotte Gentle. Baptized in 1847. Emigrated from Liverpool, England, to New Orleans, Louisiana, with his parents, arriving Oct. 28, 1848. Worked as a ship's carpenter in St. Louis, Missouri. Ordained a seventy by Elder Joseph Young, winter 1849–50. Migrated with the Warren Foote company, arriving in the Salt Lake Valley by Sept. 17, 1850. Living in Lehi, Utah, by 1851. Accompanied Brigham Young on a tour of southern Utah, 1852. Served a mission to India, 1852–55. Married Elizabeth Hardy, June 3, 1856. Participated in plural marriage. Accompanied Brigham Young on an exploring trip to the Salmon River (Idaho). Served a mission to South Africa, 1861–64, presiding over the mission. Ordained a high priest by John Blackburn, 1870. Ordained a bishop by Erastus Snow, to serve as bishop's agent in Beaver, Utah, stake, 1877. Served as mayor of Beaver. Ordained a patriarch in 1905 by Francis M. Lyman. Died Feb. 27, 1913, in Milford, Beaver Co., Utah.

Frost, Burr (1816–78). Born Mar. 4, 1816, in Wolcott, New Haven, Connecticut; son of Alpheas Frost and Elizabeth Downs. Married Mary Elizabeth Potter, Aug. 16, 1835, in Connecticut. Participated in plural marriage. Baptized Oct. 18, 1842, by Albert Merrill in Westville, Connecticut. Ordained to eighth quorum of the seventy, 1844. Migrated with the Brigham Young pioneer company as one of two skilled blacksmiths, arriving in the Salt Lake Valley by July 24, 1847. Served a mission to Australia, 1852–54. Migrated to the Salt Lake Valley from San Bernardino, California, with other missionaries in the Amasa M. Lyman company. One of the presidents of 70th quorum of the seventy. Died Mar. 16, 1878, in Salt Lake City.

Fullmer, John Solomon (1807–83). Born on July 21, 1807, in Huntington, Luzerne Co., Pennsylvania; son of Peter Fullmer and Susannah Zerfass. Married Mary Ann Price, May 24, 1837, in Davidson Co., Ten-

nessee. Participated in plural marriage. Baptized on July 29, 1839, by Joseph Smith Jr. in Nauvoo, Hancock Co., Illinois. Clerk for Joseph Smith in Nauvoo, 1841. Became a brigadier general of the Nauvoo Legion, June 3, 1842. Served a mission to Huntington, Luzerne Co., Pennsylvania, 1842–43. Agent for Joseph Smith, by 1843. Participated in exploratory mission to search for settlement sites, Mar. 1, 1845. Admitted to the Council of Fifty, Apr. 1845. Served a mission to Emmett's Camp in 1845. Member of the committee to dispose of property in Nauvoo. Migrated with the Willard Richards company as captain of ten, arriving in Salt Lake Valley, Oct. 19, 1848. Colonel of Nauvoo Legion of Utah, 1849–ca. 1857. Resident of Davis Co., Utah. Served a mission to England, 1852–54. Assigned to guide Mormon emigrants to St. Louis in 1855, leading a group from England to St. Louis, two from Philadelphia, and finally one from New York. Resident of Spanish Fork City, Utah Co., Utah. Moved to Springville, Utah, in 1861. Died Oct. 8, 1883, in Springville.

Gardner, Elias (1807-91). Born Apr. 2, 1807, in Vernon, Oneida Co., New York; son of William Gardner and Nancy Graves. Worked as a shoemaker. Married Harriet Snow Smith, Jan. 1, 1826, possibly in Massachusetts. Wife died, Mar. 1, 1830, in Lee, Berkshire Co., Massachusetts. Married Amy Pritchard, Feb. 13, 1832, in Lee. Baptized on Mar. 21, 1840, by Thomas Dutcher, probably in Portage Co., Ohio. Ordained a seventy on Oct. 7, 1841. Worked as a cooper in Morley's Settlement, Hancock Co., Illinois. Accepted into the Masonic Lodge of Nauvoo, Oct. 3, 1844. Wife died, Nov. 24, 1846, in Winter Quarters, Nebraska. Married Betsy Markham, Dec. 9, 1846, in Winter Quarters. Participated in plural marriage. Migrated to Utah with the Heber C. Kimball company, arriving in the Salt Lake Valley by Sept. 24, 1848. Second counselor to branch president James Pace in Payson, Utah, in 1851. Appointed to serve a mission in England, 1852–54. Participated in rescue parties sent to handcart companies in winter 1856. Died on Feb. 15, 1891, in Annabella, Sevier Co., Utah.

Glasgow, Samuel (1822–90). Born Feb. 6, 1822, in Glasgow, Lanarkshire, Scotland; son of John Glasgow and Elizabeth Campbell. Baptized Dec. 20, 1840, by Reuben Hadlock in Glasgow. Ordained a deacon, May 1, 1842, in Paisley, Refrewshire, Scotland. Married Josina (Josinnah) Bell.

Ordained a seventy, by Jan. 28, 1846. Wife died, June 20, 1847, in Winter Quarters, Nebraska. Married Ann Davis. Migrated with the Warren Foote company, arriving in Utah on Sept. 17, 1850. Served a mission to Scotland, 1852–55. Arrived in New Orleans, Louisiana, on Feb. 28, 1855. Returned to Utah with the John Hindley company, arriving Sept. 3, 1855. Wife died, Oct. 11, 1873. Married Susannah Sarah Farr on Mar. 23, 1874, in Salt Lake City. Lived in Ogden, Weber Co., Utah, by 1860. Died Sept. 15, 1890, in Ogden.

Glover, William (1813–92). Born Aug. 19, 1813, in Kilmarnock, Ayrshire, Scotland; son of William Glover and Catherine Owens. Emigrated to America in 1825. Married Jane Cowen in South Easton, Northampton Co., Pennsylvania, Nov. 13, 1832. Participated in plural marriage. Baptized Sept. 1842. Served as branch president in Easton, Northampton Co., in 1844. Migrated from New York on the *Brooklyn*, arriving in Yerba Buena (now San Francisco), July 31, 1846. Traveled with the Thomas Rhoades company, arriving in the Salt Lake Valley in late Sept. 1849. Served a mission to England, 1852–55. Served as one of the presidents of the 27th quorum of the seventy in England, 1855. President of the *Juventa* company of Saints emigrating from Liverpool, England, to Philadelphia in 1855. Lived in Davis Co., Utah, 1860–92. Died Mar. 31, 1892, in Farmington, Davis Co., Utah.

Graham, James (1804–57). Born Oct. 11, 1804, in Enniskillen, Fermanagh, Ireland; son of Robert Graham and Ann Barrow. Emigrated with his family from Ireland, settling in Pleasant Hill, New Castle Co., Delaware, about 1809. Married first Mary Ann Butler about 1824, probably at New Castle Co. Participated in plural marriage. Baptized probably at Bear Creek, Hancock Co., Illinois, about 1839. Possibly served a mission to Illinois to promote Joseph Smith's candidacy as president of the United States, 1844. Ordained a high priest in Nauvoo, Hancock Co., on Aug. 10, 1844. Migrated with the Howard Egan company as captain of ten, arriving in the Salt Lake Valley on Aug. 7, 1849. Served a mission to Australia, 1853–55. Died on Dec. 9, 1857, in Ogden, Weber Co., Utah.

Grant, David (1816-68). Born July 21, 1816, in Arbroath, Scotland; son of Robert Grant and Isabella Bell Mill. Emigrated aboard the *Riga*, arriving in New Orleans, Louisiana, on July 13, 1839. Baptized on Oct. 20, 1840, in Payson, Adams Co., Illinois, by David Evans. Married Mary Ann Hyde (Bullard) Sept. 18, 1843. Participated in plural marriage. Ordained a seventy. Migrated with the Brigham Young pioneer company, arriving in the Salt Lake Valley by July 21, 1847. Served a mission to England, 1852–56. Living in Salt Lake City, in 1860. Died in Mill Creek, Utah, Dec. 22, 1868.

Green, Ephraim (1807–74). Born Mar. 5, 1807, in Rodman, Jefferson Co., New York; son of Abraham Green and Mary Anna Ross. Baptized in 1839. Married to Malinda Thompson. Migrated to Nauvoo, Hancock Co., Illinois, by 1843. Married Fidelia Thompson by Feb. 6, 1846, in the Nauvoo temple. Ordained to second quorum of the seventy, Feb. 1846. Member of the Mormon Battalion, July 1846–July 1847. Migrated with the Jonathan H. Holmes/Samuel Thompson company to Salt Lake Valley, arrived Sept. 1848. Served a mission to the Sandwich Islands, 1852–55. Laid out the plan for a colony in Lanai, Hawaii, 1854. President of the 16th quorum of the seventy, Feb. 1861. Sealed to Mary DeForrest, Dec. 12, 1863. Served a mission to the Sandwich Islands with wife Mary, 1865. Died Oct. 6, 1874, in Rockport, Summit Co., Utah.

Guymon, Noah Thomas (1819–1911). Born June 30, 1819, in Jackson Co., Tennessee; son of Thomas Guymon and Sarah Gordon. Baptized Mar. 2, 1836. Married Mary Dickerson Dudley in Caldwell Co., Missouri, Dec. 24, 1837. Participated in plural marriage. Ordained a seventy, June 1, 1845, in Nauvoo, Hancock Co., Illinois. Migrated with the Aaron Johnson company, arriving in the Salt Lake Valley on Sept. 12, 1850. Served a mission to Great Britain, 1852–55. Led the company on the ship *Juventa* from Liverpool, England, arriving in Philadelphia on May 5, 1855. Returned to Utah with the Jacob F. Secrist/Noah T. Guymon pioneer company, arriving in the Salt Lake Valley, Sept. 7, 1855. Served as senior president of the 51st quorum of the seventy, May 20, 1857, Springville, Utah. Served as major in the Utah Territorial Militia, June 16, 1857. Called as a president of the

81st quorum of the seventy, Sept. 1884, Emery Co., Utah. Died Jan. 7, 1911, in Orangeville, Emery Co., Utah.

Hall, John Charles (1821–90). Born Oct. 20, 1821, in Faversham, England; son of Thomas Johnson Hall and Charlotte Wright. Baptized Nov. 17, 1847. Served a mission to England, 1852–57. Married Selina DeGrey, Apr. 26, 1853, in Dudley, England. Participated in plural marriage. Probably emigrated aboard the *George Washington*, sailing from Liverpool, England, and arriving in Boston Apr. 20, 1857. Migrated to the Salt Lake Valley in the Jesse B. Martin company, arriving in early Sept. 1857. Served as a private during the Black Hawk War, 1865–67. Living in Rockville, Kane Co., Utah, 1880. Died Mar. 3, 1890, in Rockville.

Harper, Charles Alfred (1817–1900). Born Jan. 27, 1817, in Upper Providence, Montgomery Co., Pennsylvania; son of Jesse Harper and Eleanor Evans. Married Lovina (Lavinia) Wollerton Dilworth, Dec. 19, 1839. Participated in plural marriage. Baptized May 10, 1842. Ordained a seventy by Dec. 31, 1845. Migrated with Brigham Young pioneer company to the Salt Lake Valley, arriving July 23, 1847. Served in Nauvoo Legion of Utah, Oct. 28–Nov. 9, 1850. Served mission to England, 1852–55. Led a company from Liverpool, England, aboard the ship *Juventa*, arriving in Philadelphia on May 5, 1855. Led Charles Alfred Harper company to the Salt Lake Valley, arriving Oct. 28, 1855. Settled at Big Cottonwood Precinct, Salt Lake Co., Utah. Died in Holladay, Salt Lake Co., Utah, Apr. 24, 1900.

Haven, Jesse (1814–1905). Born Mar. 28, 1814, in Holliston, Middlesex Co., Massachusetts; son of John Haven and Elizabeth Howe. Baptized Apr. 13, 1838. Ordained an elder, Jan. 10, 1839. Served a mission to the eastern United States, ca. 1840–42. Married Martha Spring Hall in Northbridge, Worcester Co., Massachusetts, Nov. 24, 1842. Participated in plural marriage. Ordained a seventy at Nauvoo, Hancock Co., Illinois, ca. 1843. Appointed a member of the 14th quorum of the seventy, Dec. 22, 1844, in Nauvoo. Served another mission to the eastern United States, ca. 1847–ca. 1849. Migrated with the Edward Hunter company as captain of ten, arriving in the Salt Lake Valley by Oct. 12, 1850. Presided over the

South Africa mission, 1852–55. Served mission in Scotland after arriving in England, 1856. Leader of a handcart company before merging with Edward Martin company, arriving in the Salt Lake Valley with the William Hodgetts company, 1856. Appointed chaplain of the Utah territorial legislature at Salt Lake City, 1856. Member of the Nauvoo Legion of Utah, 1857–ca. 1862. Appointed a circuit judge of Weber, Davis, and Morgan counties, Utah, 1862. Probate judge of Morgan Co., Utah, 1869–ca. 1876. Served as second counselor of the Weber Ward while simultaneously serving as presiding elder of the Saints in Enterprise, Weber (later Morgan) Co., Utah, 1869–76. Served as a member of the Morgan stake high council, 1877–93. Died Dec. 14, 1905, in Enterprise; buried in Salt Lake City.

Hogan, Erick (Eric) Goudyson Mibben (1802–76). Born June 23, 1802, in Randeberg, Uvdal, Buckerud, Norway; son of Gaute Erickson and Marget Knudsdatter. Christened in Randeberg, July 25, 1802. Married Kari Sondresdatter in Atraa, Telemark, Norway, June 6, 1827. Wife died, 1828. Married Helja Knutdatter Nostebein in Tinn, Telemark, Norway, Mar. 26, 1829. Participated in plural marriage. Emigrated from Norway to LaSalle Co., Illinois, arriving 1838. Anglicized name to Eric G. M. Hogan. Baptized in Iowa, Jan. 1843. Migrated to the Great Salt Lake Valley with Brigham Young company of 1848, arriving Sept. 22, 1848. Called on mission to Norway, 1852. Appointed president of the Norwegian mission, Apr. 10, 1853, and arrived May 10, 1853. Accompanied emigrating Norwegian Saints to the Great Salt Lake Valley, Nov. 10, 1854. Living in Bountiful, Davis Co., Utah, 1860. Died in Bountiful, June 21, 1876.

Hotchkiss, Lawrence Sterne (1816–1904). Born Oct. 9, 1816, in Naugatuck, New Haven Co., Connecticut; son of Thaddeus Hotchkiss and Harriet Ball. Graduated from Dartmouth College and Jefferson Medical College, Philadelphia, Pennsylvania, Mar. 10, 1837. Married Theresa G. Peyre Ferry, June 22, 1842, in Philadelphia. Wife apparently died by 1846. Married Hannah Camilla Free, Feb. 6, 1846. Baptized June 1850, possibly in Iowa. Located at Pottawattamie, Iowa, 1850. Migrated to the Salt Lake Valley, by 1850. Practiced dentistry in Utah. Ordained a seventy by Wilford Woodruff. Divorced, 1852. Called to serve a mission to Siam, 1852, but did not serve. Married Esther R. Candee, Oct. 20, 1852, possibly in

Connecticut. Moved to New Haven Co., Connecticut, by 1858. Buried Aug. 10, 1904, in New Haven.

Houtz, Jacob (1814–96). Born Oct. 12, 1814, in Penn Township, Union Co., Pennsylvania; son of Christian Houtz and Anna Elizabeth Zeller. Married Lydia Mease on Feb. 22, 1838, in Pennsylvania. Participated in plural marriage. Baptized in Oct. 1844. Ordained a member of the sixth quorum of the seventy, Apr. 1846. Migrated with the Daniel Spencer/Ira Eldredge company, arriving in the Salt Lake Valley by Sept. 23, 1847. Appointed second counselor of the Salt Lake Fifth Ward, ca. 1847. Served as second counselor of the Salt Lake Sixth Ward, 1849–50. Called to serve a mission to Berlin, Prussia, 1852. Arrived in Berlin but was deported and spent the rest of his mission in England and probably US, 1853. Served as second counselor of the Salt Lake Eighth Ward, 1856–61. Served a mission to the eastern United States, 1869–70. Elected a member of Springville city council in Springville, Utah Co., Utah, 1871. Died on Dec. 11, 1896, in Springville.

Hunt, John Alexander (1830-1913). Born May 16, 1830, in Gibson Co., Tennessee; son of Daniel Durham Hunt and Nancy Davis. Baptized in Nauvoo, Hancock Co., Illinois, Mar. 15, 1843. Ordained a seventy in Nauvoo, Feb. 1, 1847. Resided with his family in Pottawatomie Co., Iowa, Jan. 22, 1848. Migrated to Great Salt Lake Valley in Aaron Johnson company, arriving Feb. 12, 1850. Called on a mission to Great Britain, Aug. 28, 1852; arrived Jan. 3, 1853. Appointed president of Warwickshire conference, Feb. 10, 1855. Left Liverpool on the *Enoch Train*, arriving in Boston on May 1, 1856. Led the John A. Hunt company, the last to leave Florence, Nebraska, in 1856, arriving in the Salt Lake Valley on Dec. 10, 1856, after suffering much hardship. Ran mail station at Devil's Gate, summer 1857. Married Elizabeth Tilt in Salt Lake City, Sept. 22, 1859. Resided in Grantsville, Tooele Co., Utah Territory, 1859-64. Moved to St. Charles, Bear Lake Co., Idaho. Served as county commissioner for Tooele and Bear Lake Counties. Called as first bishop of St. Charles Ward, Aug. 25, 1877, serving until 1895. Died Jan. 23, 1913, in St. Charles.

Hyde, John (1803-53). Born June 4, 1803, in Stockport, Cheshire, England; son of Robert Hyde and Ellen Maycock. Baptized by June 1, 1849. Hyde, William (1818-74). Born Sept. 11, 1818, in present-day York, Livingston Co., New York; son of Heman Hyde and Polly Wyman Tilton. Baptized Apr. 7, 1834. Served mission to Illinois, Indiana, and Michigan, Nov. 1839-Feb. 1840. Ordained to quorum of the seventy, Apr. 7, 1840. Began serving mission to Maine, Apr. 1840. Married Elizabeth Howe Bullard in Hancock Co., Illinois, Feb. 25, 1842. Participated in plural marriage. Served mission to Vermont, Oct. 1842-June 1843; to eastern states, Sept. 1843-Aug. 1844; to Mississippi and Alabama, Jan. 1845-Mar. 1845. Ordained a president of the eighth quorum of the seventy, Oct. 8, 1844. Joined Mormon Battalion, July 16, 1846; appointed sergeant of company B. Migrated from California Territory to Great Salt Lake Valley with Levi W. Hancock/Jefferson Hunt/James Pace/Andrew Lytle company, arriving by Oct. 16, 1847. Appointed to serve mission to Australia, Aug. 1852. Appointed a president of the 44th quorum of the seventy, May 1857. Appointed bishop of Hyde Park, Cache Co., Utah, July 1, 1860. Led William Hyde company from Nebraska Territory to Great Salt Lake Valley, arriving Oct. 26, 1864. Ordained a patriarch, June 27, 1873. Died in Hyde Park, Mar. 2, 1874.

Jeremy, Thomas Evans (1815–91). Born July 11, 1815, in Llanegwad Parish, Carmarthenshire Co., Wales; son of Thomas Jeremy and Sarah Evans. Married Sarah Evans, Mar. 16, 1838, Carmarthenshire Parish, Wales. Baptized Apr. 3, 1846, by Dan Jones in Carmarthenshire, Wales. Participated in plural marriage. Emigrated from Liverpool, England, aboard the *Buena Vista*, arriving in New Orleans, Louisiana, Apr. 19, 1849. Migrated July 14, 1849, to Salt Lake Valley, arriving Oct. 1849. Served mission to Wales, 1852–55. Presided over the districts of Western Glamorganshire, Llanelly, and Carmarthen, 1853. Sustained counselor of the church in Wales, June

26, 1853. Served a second mission to Wales; appointed president of the Welsh mission, Jan. 20, 1861. Released Mar. 26, 1864. Appointed member of the Salt Lake Stake high council, Oct. 9, 1864. Ordained a patriarch, 1887. Died Apr. 17, 1891, in Salt Lake City, Utah.

Johnson, Benjamin Franklin (1818–1905). Born on July 28, 1818, in Pomfret, Chautauqua Co., New York; son of Ezekiel Johnson and Julia Hills. Baptized in Kirtland, Geauga Co., Ohio, spring 1835. Ordained an elder in Far West, Caldwell Co., Missouri, Mar. 10, 1839. Served mission to eastern United States and Upper Canada, 1840-41. Married Melissa B. LeBaron in Kirtland, Dec. 25, 1841. Participated in plural marriage. Ordained a high priest at Ramus, Hancock Co., Illinois, ca. 1843. Admitted to Council of Fifty, spring 1844. Migrated with Willard Richards company to the Great Salt Lake Valley, arriving Oct. 10, 1848. Appointed captain in Nauvoo Legion of Utah, May 1849. Appointed member of the provisional state of Deseret house of representatives, 1849. Presided over Summit Creek Branch in Utah Co., Utah, 1851–52. Served Mission to Sandwich Islands, 1852–55. Presided over Santaquin Branch in Utah Co., 1856–58. Presided over Spring Lake Branch in Utah Co., 1862–77. Served mission in Utah, 1877; instructed Saints on importance of temple work. Served as bishop of Spring Lake Ward in Utah Co., 1877–82. Ordained a patriarch in Arizona Territory, Jan. 7, 1883. Served mission to Yaqui Indians, 1884. Died on Nov. 18, 1905, in Mesa, Maricopa Co., Arizona.

Jolley, Washington Lafayette (1831–89). Born May 14, 1831, in Dresden, Weakley Co., Tennessee; son of Reuben Manning Jolley and Sarah Pippen. Living in Nauvoo, Hancock Co., Illinois, in 1842. Baptized in 1842 by Peter Hawes. Moved to Iowa, May 1846. Migrated with the Warren Foote company, arriving in the Salt Lake Valley on Sept. 17, 1850. Living in Pleasant Grove, Utah Co., Utah, in 1851. Living in Salt Lake 13th Ward, 1851. Called on a mission to Texas, Aug. 1852. Married Emily Knight, Apr. 3, 1854. Led a group of Texas Saints to the Salt Lake Valley, arriving Sept. 21, 1854. Living in Payson, Utah Co., Utah, in 1860. Called on a mission to the southern states, Sept. 22, 1860, returning to Utah with the David H. Cannon company, arriving in Payson Aug. 15, 1861. Called as a member of the cotton mission to southern Utah, Oct. 19,

1862. Served as major of the Washington battalion in the Iron Co., Utah, military district in 1865. Living in Washington, Washington Co., Utah, in 1870–80. Died on Nov. 8, 1889, in Washington.

Jones, Dan (1810–62). Born on Aug. 4, 1810, in Caerfallwch, Wales; son of Thomas Jones and Ruth Roberts. Married Jane Melling in Denbigh, Wales, Jan. 3, 1837. Immigrated to United States, ca. 1840. Baptized on Jan. 19, 1843, in Mississippi River. Served mission to Wales, 1845–49. Presided over the church in Wales, 1845–49. Appointed to preside over the Merthyr Tydfil conference, 1846. Migrated with the George A. Smith/Dan Jones company, captain of the Welsh Saints and marshal, arriving in the Salt Lake Valley between Oct. 25 and 29, 1849. Elected first mayor of Manti, Sanpete Co., Utah, Apr. 1851. Ordained a high priest by 1851. Served a second mission to Wales, 1852–56. President of church's Welsh principality, 1854–56. Captain of the Dan Jones company (later called John A. Hunt company) for a time, 1856. Died on Jan. 3, 1862, in Provo, Utah Co., Utah.

Jones, Nathaniel Vary (1822–63). Born Oct. 13, 1822, in Brighton, Monroe Co., New York; son of Samuel Jones and Lucinda Kingsley. Baptized Apr. 6, 1842. Served mission to eastern states, 1843–44. Ordained to seventh quorum of the seventy, Oct. 8, 1844. Married Rebecca M. Burton in Nauvoo, Hancock Co., Illinois, Mar. 14, 1845. Participated in plural marriage. Served in Mormon Battalion. Migrated to Great Salt Lake Valley with Howard Egan company, arriving Aug. 7, 1849. Appointed to serve mission to Asia, Aug. 28, 1852. Ordained a high priest, Sept. 14, 1852. Ordained bishop of Salt Lake 15th Ward, Sept. 14, 1852. Served mission to Calcutta, 1853–55. Appointed president of Calcutta Mission, Apr. 29, 1853. Served mission to England, 1859–61. Died on Feb. 15, 1863, in Salt Lake City.

Karren, Thomas (1810–76). Born on May 1, 1810, in Onchan, Isle of Man, England; son of Thomas Kerran and Catherine Clark. Worked as a baker and farmer. Married Ann Ratcliffe, May 5, 1833, in Liverpool, England. Baptized May 7, 1842, in England. Immigrated to the US, possibly on the *Isaac Allerton*, arriving in New Orleans, Louisiana, late Mar. 1844.

Migrated to Nauvoo, Hancock Co., Illinois. Enlisted with the Mormon Battalion at Mount Pisgah, Iowa; served with E company. Became ill and wintered over in Pueblo, Colorado, 1846–47. Migrated to Utah with the Mormon Battalion sick detachments company, arriving in July 1847. Traveled to Garden Grove, Iowa, to reunite with his family, migrating again to Utah in 1850. Assigned by Brigham Young to settle what became Lehi, Utah Co., Utah, 1850. Served a mission to the Sandwich Isles (Hawaii), 1852–55. Participated in plural marriage. Appointed to various city positions in Lehi. Served as counselor to Bishop David Evans in Lehi. Died Apr. 4, 1876, in Lehi.

Lambson, Alfred Boaz (1820–1905). Born Aug. 27, 1820, in Royalton, Niagara Co., New York; son of Boaz Lambson and Polly Walworth. Moved from Kinderhook, Branch Co., Michigan, to Nauvoo, Hancock Co., Illinois, in 1843. Baptized Apr. 4, 1844, in Nauvoo. Ordained a seventy on Apr. 13, 1844, in Nauvoo. Left Nauvoo on June 4, 1844, to serve a mission in Virginia. Called back to Nauvoo after the murder of Joseph Smith, arriving on Dec. 21, 1844. Married Melissa Jane Bigler, Nov. 25, 1845, in Nauvoo. Assisted with the building of wagons in Winter Quarters, Nebraska, 1845–47. Migrated to Utah with the Daniel Spencer/Perrigrine Sessions company, arriving Sept. 25, 1847. Appointed to serve a mission to the West Indies, Aug. 1852. Arrived in Jamaica, Jan. 10, 1853. Returned home because of opposition and finished mission in Michigan. Lived in Florence, Nebraska, 1856–66, outfitting and blacksmithing emigrant wagon trains. Returned to Utah in 1866. Died on Feb. 26, 1905, in Salt Lake City.

Lamoreaux, Andrew Losey (1812–55). Born Mar. or Oct. 17, 1812, in Scarborough or Pickering, York, Ontario, Canada; son of John McCord Lamoreaux and Abigail Ann Losey. Married Isabell Rodgers Wilson in Markham, York, Ontario, Canada, Oct. 12, 1833. Participated in plural marriage. Baptized in June 1837 in Ontario. Ordained an elder in Kirtland, Geauga Co., Ohio; signed the Kirtland Camp constitution, Mar. 1838. Received into the high priest quorum in Nauvoo, Hancock Co., Illinois, on Dec. 17, 1843; 10th quorum of the seventy on Oct. 8, 1844. Remained in Nauvoo to protect the property of those who remained; participated as

captain in the "battle of Nauvoo," Sept. 1846. Migrated with the Willard Richards company, arriving in the Salt Lake Valley, Oct. 10, 1848. Elected to represent Davis Co. in the territorial government, Aug. 21, 1852. Presided over the French Mission, 1852–55. Died June 13, 1855, in St. Louis, Missouri.

Lawson, James (1820–1912). Born July 20, 1820, in Kinross, Scotland; son of David Lawson and Margaret Anderson. Baptized in Scotland, Sept. 10, 1840. Married Margaret Thomson (Thompson) in Glasgow, Scotland, Apr. 28, 1841. Wife died in Glasgow, Oct. 4, 1842. Emigrated on the ship *Metoka* from Liverpool, England, to New Orleans, Louisiana, arriving Oct. 27, 1843. Arrived in Nauvoo, Hancock Co., Illinois, May 14, 1845. Ordained a seventy in Nauvoo, May 18, 1845. Migrated to Utah with the Daniel Spencer/Perrigrine Sessions company, arriving ca. Sept. 25, 1847. Appointed to mission in Iron Co., Utah, and, with others, smelted the first iron that was discovered in that region. Served missions in Sandwich Islands (Hawaii), 1852–55, 1865–67. Presided over church in Molokai, 1854–55. Married Elizabeth Ann Noon in Salt Lake City, Oct. 10, 1855. Participated in plural marriage. Served mission in Carson Valley, Utah (later Nevada). Ordained a patriarch, 1903. Died in Salt Lake City, Sept. 14, 1912.

Leonard, Truman (1820–97). Born Sept. 17, 1820, in Middlesex, Ontario Co., New York; son of Truman Leonard Sr. and Roxanna Allis. Baptized Mar. 25, 1834. Served a mission to Ohio and New York in 1843. Married Ortensia White, Jan. 1, 1846, in Nauvoo, Hancock Co., Illinois. Participated in plural marriage. Migrated to Salt Lake Valley from Kanesville (later Council Bluffs), Iowa, with the William Snow/Joseph Young company, arriving by Oct. 4, 1850. Ordained a seventy on June 11, 1843, by Noah Packard. Served a mission to India, 1852–55. Emigrated from Liverpool, England, on the *Enoch Train*, arriving in Boston May 1, 1856. Migrated to Utah in the Daniel D. McArthur handcart company, leaving Iowa City, Iowa, on June 11, 1856, and arriving on Sept. 26, 1856. Appointed senior president of the 56th quorum of the seventy, Sept. 1854. Member of Deseret Brass Band. Died Nov. 20, 1897, in Farmington, Davis Co., Utah.

Lewis, James (1814–98). Born Jan. 12, 1814, in Gorham, Cumberland Co., Maine; son of James Lewis and Hannah Harding. Moved to Missouri in 1840. Baptized and ordained an elder, Feb. 1842, in Keokuk, Iowa. Served a fund-raising mission to the eastern states, 1843. Returned to St. Louis, Missouri, 1844. Ordained a seventy, Feb. 22, 1845. Married Emily Jennison Holman, May 9, 1847. Participated in plural marriage. Immigrated to the Salt Lake Valley in the Silas Richards company, arriving in the Salt Lake Valley in late Oct. 1849. Served a mission to southern Utah, 1850; to China, 1852–54. Elected representative to the territorial legislature, 1855–57. Probate judge of Iron Co., Utah. Removed to Kanab, Kane Co., Utah, in 1871. Elected commissioner of Kane Co., 1872. Worked in the St. George Temple, 1879–82. Called on a mission to San Juan, Utah, 1882; appointed judge of San Juan Co. Lived in Taylor, Apache Co., Arizona, until 1891. Removed to Kanab, Oct. 1891. Called as a patriarch Sept. 8, 1895. Died May 28, 1898, in Kanab.

Luddington, Elam (1806–93). Born on Nov. 23, 1806, in Litchfield Co., Connecticut; son of Elam Luddington and Aseneth (Sena) Munger. Living in New York City, New York, by 1834. Baptized May 16, 1840, in Nauvoo, Hancock Co., Illinois, possibly by Joseph Smith. Married Mary Elizabeth Clark, May 16, 1841, in Nauvoo. Participated in plural marriage. Proselytized in New Orleans, Louisiana, 1841–43. Served a mission to Quincy, Illinois, June 1844; to New Orleans, fall 1844. Ordained a high priest on Sept. 15, 1844. Served a mission to Mississippi, 1844–45. Member of the Mormon Battalion, July 1846–July 1847. Migrated to Utah with the Mormon Battalion sick detachments, arrived July 29, 1847, with his wife, daughter, and mother. Appointed a city marshal, assessor, and collector for Salt Lake City, winter 1849. Served a mission to Siam, 1852–55. Appointed as president of East India Mission and Calcutta Branch. Member of Captain Killan's company, Utah War, 1857–58. Died Mar. 3, 1893, in Salt Lake City.

Martin, Edward (1818–82). Born Nov. 18, 1818, in Preston, England; son of John Martin and Ann Slater. Baptized by Orson Hyde on Oct. 14, 1837. Married Alice Clayton, ca. 1840. Participated in plural marriage.

Emigrated aboard the *Sheffield* from Liverpool, arriving in New Orleans, Louisiana, Mar. 30, 1841. Ordained a seventy in Nauvoo, Hancock Co., Illinois, Oct. 9, 1844. Appointed a president of the 24th quorum of seventy in Nauvoo, Apr. 9, 1845. Served in the Mormon Battalion. Migrated to the Salt Lake Valley with the Levi W. Hancock/Jefferson Hunt/James Pace/Andrew Lytle company, arriving by Oct. 16, 1847. Served a mission to England, 1852–56. Captain of the Edward Martin handcart company, 1856. Died Aug. 8, 1882, in Salt Lake City.

Mayer, George (1805–96). Born Mar. 2, 1805, in York Co., Pennsylvania; son of Abraham Mayer and Elizabeth Lauck. Married Ann Yost in Bucyrus, Crawford Co., Ohio, Mar. 4, 1828. Participated in plural marriage. Served in the military in Bucyrus, Ohio, 1830. Baptized in Logansport, Cass Co., Indiana, Nov. 11, 1843. Ordained elder, Mar. 5, 1844. Ordained a seventy, Jan. 12, 1845. Appointed senior president of the Nauvoo 32nd quorum of the seventy, Dec. 21, 1845. Migrated to Great Salt Lake Valley in the Heber C. Kimball company, arriving Sept. 24, 1848. Served mission to Germany and Switzerland, 1852–55. Served mission to Las Vegas, New Mexico Territory (now Nevada), 1856–57. Appointed president over the quorums of the seventy in Spanish Fork, Utah. Ordained a high priest, Dec. 10, 1893. Ordained a patriarch, Apr. 19, 1896. Died in Spanish Fork, July 24, 1896.

Mayer, John (1811–92). Baptized Nov. 7, 1813, in Burslem, Staffordshire, England; son of William and Frances Mayer. Married Sarah Minshall, 1831, in Saint Giles, Newcastle-under-Lyme, Staffordshire, England. Practiced plural marriage. Baptized before Dec. 1, 1838. Emigrated from Liverpool, England, aboard the *Champion*, arriving with his family in New Orleans, Louisiana, Dec. 6, 1843. Migrated with the Warren Foote company, arriving in the Salt Lake Valley on Sept. 17, 1850. Worked as a bricklayer and mason. Served a mission to Great Britain, 1852–55. Settled in Los Angeles, California, 1861. Died Jan. 23, 1892, in Los Angeles, California.

McArthur, Daniel Duncan (1820–1908). Born Apr. 8, 1820, in Holland, Niagara Co., New York; son of Duncan McArthur and Susan

McKeen. Baptized 1838. Married Cordelia Clark, June 14, 1841; she died June 14, 1844. Ordained to 10th quorum of the seventy, Oct. 8, 1844. Married Matilda Caroline Fuller, Dec. 14, 1845. Participated in plural marriage. Migrated from Winter Quarters, unorganized US territory (later in Omaha, Douglas Co., Nebraska) to Great Salt Lake Valley with Brigham Young company, arriving by Sept. 24, 1848. Appointed to mission in England, by Aug. 29, 1852. Led Daniel D. McArthur company from Iowa City, Johnson Co., Iowa, to Great Salt Lake Valley, arriving Sept. 26, 1856. Appointed major in Nauvoo Legion of Utah, 1857. Called to settle southern Utah, by Oct. 9, 1861. Became bishop of Third Ward, St. George, Washington Co., Utah, Mar. 22, 1862. Assisted Saints coming to Great Salt Lake Valley, 1863, 1868. Called as presiding bishop in southern Utah, Sept. 15, 1869. Called on mission to Europe, by Apr. 7, 1877. Set apart as president of St. George stake, Dec. 17, 1888. Ordained a patriarch, June 1901. Died in St. George, June 3, 1908.

McBride, William (1807–95). Born Mar. 22, 1807, in Sugar Creek, Greene Co., Ohio; son of James McBride and Margaret Jane Andrew. Married Elizabeth Harris Ball Boorham, Sept. 1, 1831, at Randolph, Montgomery Co., Ohio. Participated in plural marriage. Baptized Oct. 28, 1843, by Henry Elliot. Ordained a president of 26th quorum of the seventy, 1845. Migrated with the Willard Richards company, arriving in the Salt Lake Valley, Oct. 10, 1848. Served a mission to the Sandwich Islands, 1852–55. Led the William McBride company, arriving in the Salt Lake Valley July 21, 1855. Served as presiding elder of Santaquin, Utah Co., Utah, branch, 1858–65. Served as a major in the Nauvoo Legion of Utah, 1866. Ordained patriarch of the Pima, Arizona, stake, 1877. Died Mar. 6, 1895, in Salt Lake City.

McDonald, John Kilpatrick (1797–1874). Born Jan. 5, 1797, in Donaghadee, Ireland; son of William McDonald and Agnes (Nancy) Kilpatrick. Cabinet maker. Married Rachel Burck Taffee, Apr. 1823, in Lurgan, Ireland. Immigrated to Canada about 1831; lived in Quebec. Lived in Philadelphia, Pennsylvania, in 1834. Lived in Pittsburgh, Allegheny Co., Pennsylvania, 1838–42. Baptized June 1842 by John E. Page, probably in Pittsburgh. Living in Nauvoo, Hancock Co., Illinois, in fall 1842. Went

to St. Louis, Missouri, for work; returned to Nauvoo by June 29, 1844. Ordained a seventy on Apr. 9, 1845, in Nauvoo, Illinois. Worked on the Nauvoo Temple and built wagons for the migration to Utah. Traveled to Utah with the Ezra T. Benson company in 1849; returned east (possibly to Nebraska or Iowa) to his family. Moved to Utah with the Warren Foote company, arriving Sept. 17, 1850. Called to serve a mission to Ireland and England, 1852–56. Served as the president of the Belfast Conference and Londonderry Branch in Ireland. Wife died by Apr. 29, 1863. Married Sarah Johnson, Dec. 26, 1863, in Salt Lake City. Participated in plural marriage. Died Aug. 31, 1874, in Salt Lake City.

Miller, Daniel Arnold (1809-81). Born Aug. 11, 1809, in Lexington, Greene Co., New York; son of James Gardner Miller and Ruth Arnold. Moved to Quincy, Adams Co., Illinois, ca. 1829. Married Clarissa Pond, Dec. 29, 1833. Baptized Sept. 1839. Moved to Hancock Co., Illinois, 1840. Ordained a high priest, Nov. 1840. Appointed bishop in Columbus, Adams Co., Illinois, Oct. 27, 1840. Member of the Nauvoo Legion. Served mission in Indiana, 1843-44. Wife died, Sept. 1, 1844. Married Hannah Bigler, Hancock Co., Illinois, Dec. 29, 1844. Participated in plural marriage. Moved to Iowa Territory, 1846. Appointed bishop, or manager, of Council Bluffs, Iowa, July 21, 1847. Immigrated to Great Salt Lake Valley with William Perkins company; arriving Sept. 4, 1848. Accompanied Apostle George A. Smith to begin settlement in Little Salt Lake Valley (later Parowan), Utah, Dec. 1850. Served mission to Iowa, 1852; assigned to bring ammunition, books, and other items back to Utah. Director of Farmington Co-op, 1869–81; director, and later president, of Davis Co. Co-op, 1876-81. Died in Providence, Cache Co., Utah, Dec. 4, 1881. Buried in Farmington, Davis Co., Utah.

Millett, Joseph (1832–1911). Born Dec. 12 or 22, 1832 or 1833, in Ernestown, Ontario, Canada; son of Artemas Millet and Susannah Peters. Baptized by Apr. 1, 1842. Married Sarah E. Glines, Mar. 26, 1854, in Lowell, Massachusetts. Family moved to Kirtland, Geauga Co., Ohio, 1834. Moved to Nauvoo, Hancock Co., Illinois, by Apr. 1843. Migrated to Salt Lake Valley with the David Evans company, arriving Sept. 15, 1850. Served a mission to Nova Scotia and the British provinces, 1852–53; to

New England, 1854. Returned to Salt Lake Valley with the Canute Peterson company, arriving Sept. 19, 1856. Settlement mission to southern Utah, 1866–75. Moved to Arizona, 1878. Died on Oct. 11, 1911, in Cedar City, Iron Co., Utah.

Mitchell, Benjamin Thomas (1816–80). Born Jan. 12, 1816, in Muncy, Lycoming Co., Pennsylvania; son of Abraham Mitchell and Annie Colpetzer. Married Sarah Treicbach in Portage, Wood Co., Ohio, Apr. 26, 1835. Participated in plural marriage. Baptized June 15, 1836. Worked as stonecutter for Nauvoo Temple. Ordained to third quorum of the seventy, Oct. 6, 1844. Migrated to the Great Salt Lake Valley with Heber C. Kimball company, arriving Sept. 24, 1848. Served mission to Nova Scotia and British provinces, 1852–54. Led the Benjamin Thomas Mitchell company to the Great Salt Lake Valley, arriving Aug. 5, 1854. Oversaw stonecutting for Salt Lake Temple, 1854–64. Called as bishop of Salt Lake 15th Ward, Dec. 24, 1856. Appointed a captain of the Nauvoo Legion of Utah. Died in Salt Lake City, Mar. 9, 1880.

Musser, Amos Milton (1830–1909). Born May 20, 1830, in Donegal, Lancaster, Pennsylvania; son of Samuel Musser and Anna Barr. Baptized May 24, 1851, at Kanesville, Iowa. Migrated to the Salt Lake Valley with the Easton Kelsey company, arriving Sept. 1851. Served a mission to India, 1852–56. Labored in England and Wales, 1857. Married Ann Leaver, Jan. 31, 1858. Wrote the pamphlet *Fruits of Mormonism* and the periodicals *Utah Farmer* and *The Palantic*. Worked in the Church Historian's Office, 1896; sustained as an Assistant Church Historian, 1902. Died Sept. 24, 1909, in Salt Lake City.

Nickerson, Levi Stillman (1814–1853). Born Apr. 2, 1814, in Springville, Susquehannah Co., Pennsylvania; son of Freeman Nickerson and Hulda Chapman. Baptized June 1833. Member of Camp of Israel. Ordained to priesthood, fall 1835, in Kirtland, Geauga Co., Ohio. Assisted in moving the Saints from Missouri, winter 1838–39. Married Mary Ann

Neyman, June 1840. Appointed to a mission with his father in Peoria, Illinois, July 1840. Ordained as a president of the fourth quorum of the seventy, Oct. 8, 1844. Migrated to Utah with the Edward Hunter company, arriving Oct. 1, 1850. Appointed to a mission in Europe, Oct. 13, 1852. Died Dec. 15, 1853, in Kanesville (now Council Bluffs), Iowa.

Norton, John Warren (1810–63). Born May 12 or 13, 1810, in Franklin Co., Tennessee; son of William Norton and Hester, Esther, or Easter James. Cotton grower and processor, and farmer. Married Dorothy Osborn, Oct. 17, 1830, in Franklin Co., Tennessee. Moved to Shelby Co., Tennessee, about 1835. Baptized Aug. 12, 1840. Moved to Tippah Co., Mississippi. Moved to Nauvoo, Hancock Co., Illinois, early 1846. Moved to Lee Co., Iowa. Wife died in Lee Co., Sept. 6, 1846. Moved to Mount Pisgah settlement, Union Co., Iowa. Married widow Martha Ann Covington Gay, 1846 or 1847. Migrated to Utah Territory with the John Brown company and arrived Sept. 29, 1851. Divorced. Probably ordained a high priest Apr. 6, 1852. Appointed to serve a mission to Australia and arrived in Sydney, Australia, Mar. 3, 1853. Returned from mission, late 1850s. Resided in Provo, Utah Co., Utah Territory, by Sept. 13, 1860. Moved to Nephi, Juab Co., Utah. Married widow Ann Jackson Baxter, Oct. 17, 1863, and moved to southern Utah. Died Nov. 28, 1863, in Springdale, Washington Co., Utah.

Oakley, John Degroot (1819–90). Born Nov. 12, 1819, in Flatlands, Kings Co., New York; son of Ezra Oakley and Elizabeth Degroot. Baptized in North River at New York City, Sept. 4, 1840. Ordained a seventy, Oct. 8, 1844. Married Mary Madalena McCormall Patterson in Nauvoo, Hancock Co., Illinois, Feb. 16, 1845. Member of Nauvoo Legion. Migrated to Great Salt Lake Valley with Edward Hunter/Joseph Horne company, arriving Sept. 29, 1847. Served mission to England, 1852–56. Participated in rescue companies that assisted struggling companies across plains, 1856. Died on May 4, 1890, in Snowflake, Apache Co., Arizona Territory.

Owens, Robert (1818–83). Born July 10, 1818, probably in Dover, Kent Co., Delaware; son of Edmund H. Owens and Margaret Turner. Married Catherine Ann Williams, 1837. Participated in plural marriage. Baptized and ordained a seventy, Sept. 21, 1844. Appointed to 34th quorum of the

seventy, Feb. 5, 1846. Served in Mormon Battalion, 1847. Migrated to Great Salt Lake Valley in Levi W. Hancock/Jefferson Hunt/James Pace/Andrew Lytle company, arriving by Oct. 16, 1847. Appointed to serve mission to India, Aug. 1852. Died on Nov. 8, 1883, in Los Angeles, California.

Pace, James (1811-88). Born June 15, 1811, in Rutherford Co., Tennessee; son of James Pace and Mary Ann Loving. Married Lucinda Gibson Strickland in Murfreesboro, Rutherford Co., Tennessee, Mar. 20, 1831. Participated in plural marriage. Baptized by Dominicus Carter, Apr. 14, 1839. Ordained a seventy in Nauvoo, Hancock Co., Illinois, Oct. 1840. Served mission to Illinois, 1843; to Arkansas, 1844. Appointed to fourth quorum of the seventy, Oct. 8, 1844. Appointed as a president of 17th quorum of the seventy, Jan. 12, 1845. Enlisted in Mormon Battalion, July 16, 1846. Led Mormon Battalion veterans to Great Salt Lake Valley in Levi W. Hancock/Jefferson Hunt/James Pace/Andrew Lytle company, arriving by Oct. 16, 1847. Led James Pace company to Great Salt Lake Valley, arriving Sept. 23, 1850. Appointed branch president in Payson, Utah Co., Utah, by 1851. Appointed to serve mission to England, Aug. 28, 1852. Appointed to presidency of Bedfordshire conference, by Jan. 1854. Appointed to serve mission to southern Utah, Oct. 1861. Elected president of United Order in Washington Co., Utah, by Dec. 22, 1876. Moved to southern Arizona Territory, Nov. 1882. Died Apr. 6, 1888, in Thatcher, Graham Co., Arizona Territory.

Park, James Pollock (1821–89). Born Dec. 21, 1821, in Cambuslang, Scotland; son of Andrew Park and Jane (Jean) Pollock. Immigrated to Canada, by 1842. Baptized in Canada, 1844. Appointed to ninth quorum of the seventy at Nauvoo, Hancock Co., Illinois, Oct. 8, 1844. Ordained an elder, ca. 1845. Appointed to serve mission to Canada, ca. 1845. Enlisted in Mormon Battalion at Council Bluffs, Iowa Territory, July 16, 1846. Migrated to Great Salt Lake Valley in Ebenezer Brown company, arriving Oct. 10, 1848. Married Agnes Findley in Big Cottonwood, Utah, Sept. 21, 1849. Participated in plural marriage. Served mission to British Isles, 1852–57. Presided over Saints emigrating from Liverpool, England, to Boston on ship George Washington, spring 1857. Led Christian Christiansen company

to Great Salt Lake Valley, arriving Sept. 13, 1857. Appointed as a president of 61st quorum of the seventy at Millcreek, Salt Lake Co., Utah, Feb. 25, 1859. Appointed to serve in cotton mission in Washington Co., Utah, Oct. 19, 1862. Died on Dec. 30, 1889, in Fairfield, Utah Co., Utah.

Parry, John (1799–1855). Born June 22, 1799, in Bishops Frome, Herefordshire, England; son of Richard Parry and Elizabeth Price. Married Anne Williams in Ashperton, Herefordshire, England, Nov. 14, 1822. Baptized in Herefordshire, England, Mar. 8, 1840. Ordained a seventy, Mar. 17, 1840. Arrived in New York on ship *North America*, Oct. 12, 1840. Migrated to Great Salt Lake Valley with Charles C. Rich company, arriving Oct. 2, 1847. Appointed to Salt Lake stake high council, Sept. 8, 1850. Served mission to British Isles, 1852–55. Died on July 19, 1855; buried in Mormon Grove, Atchison Co., Kansas Territory.

Peterson (Petersen), Canute (Knud) (1824–1902). Born May 7, 1824; christened May 9, 1824, in Ulvik, Hordaland, Norway; son of Peder Jonsen and Herborg Knudsdatter. Emigrated 1837. Moved to LaSalle Co., Illinois, in 1837. Baptized at Fox River Settlement, La Salle Co., Illinois, Sept. 12, 1842. Ordained a seventy in Nauvoo, Hancock Co., Illinois, May 13, 1845. Appointed to serve mission in Wisconsin, Nov. 1844–45. Married Sarah Ann Nelson in Council Bluffs, Iowa, July 3, 1849. Migrated to Great Salt Lake Valley with the Ezra T. Benson company, arriving Oct. 25, 1849. Appointed to settle Dry Creek (now Lehi), Utah, July 1850. Appointed a mission to Norway, Aug. 28, 1852. Returned to Utah in the Canute Peterson company, arriving Sept. 16, 1856. Participated in plural marriage. Served as counselor to Bishop David Evans in Lehi, Utah, 1863-67. Called to settle in Sanpete Co., Utah; appointed bishop of Ephraim Ward in 1867. Served as representative in Utah legislature, 1876–82. Appointed to preside over Scandinavian mission, 1871-73. Sustained as stake president of Sanpete, Utah, stake, July 4, 1877. Sustained as a patriarch, Nov. 20, 1897. Sustained as president of the South Sanpete, Utah, stake, Dec. 9, 1900. Died in Ephraim, Sanpete Co., Utah, Oct. 14, 1902.

Piercy, George (also known as Hans Peter Olsen) (1821–65). Born June 17, 1821, in Forshayn, Foroe Island, Denmark; son of Ole Justinussen

(Gustinussen) and Ane Marie Svendsen. Worked as a sailor. Baptized Apr. 20, 1849. Migrated to Utah by 1851. Appointed mission to Denmark, Aug. 1852, and spent ten months on the island of Bornholm. Appointed president of Copenhagen, Denmark, conference, Oct. 6, 1853. Brought group of Scandinavian converts from Copenhagen, Denmark, to Hull, Yorkshire Co., England, Jan. 1854. Appointed captain of Saints who sailed from Liverpool, England, on the ship *Benjamin Adams*. Married Catherine Ingreberg (Ingeborg) Neilson, Feb. 1854. Arrived in New Orleans, Louisiana, on Mar. 22, 1854. Migrated to Great Salt Lake Valley as captain of Hans Peter Olsen company, arriving Oct. 5, 1854. Moved to American Fork, Utah Co., Utah, by 1856. Appointed to Carson Valley, Utah (now Nevada), 1856. Appointed to Muddy Mission in 1865 and settled at St. Joseph, Yavapai Co., Arizona. Died in St. Joseph, Oct. 24, 1865.

Pitt, William (1813–73). Born Aug. 16, 1813, in Dymock, Gloucestershire, England; son of Robert Pitt and Hannah Hill. Baptized June 13, 1840. Married Caroline Smith, Apr. 28, 1841, in West Bromwich, Staffordshire, England. Emigrated from Liverpool, England, to New Orleans, Louisiana, with wife and two children, arriving Apr. 26, 1842. Elected captain of the Nauvoo Brass Band, 1842. Worked as a carpenter and painter on the Nauvoo Temple, 1844–45. Served in the Nauvoo Legion. Wife died Feb. 14, 1844, in Nauvoo, Illinois. Ordained a seventy, 1844. Married Cornelia Melvina Devine in Nauvoo, Illinois, Dec. 12, 1844. Migrated to the Great Salt Lake Valley in Edward Hunter company, arriving Oct. 13, 1850. Served mission to England, 1852–55. Migrated to Great Salt Lake Valley in Richard Ballantyne company, arriving Sept. 25, 1855. Wife died in Salt Lake City, Aug. 21, 1860. Married Mary Jane Collins in Salt Lake City, Dec. 12, 1861. Died Feb. 21, 1873.

Porter, Nathan Tanner (1820–97). Born July 10, 1820, in Corinth, Orange Co., Vermont; son of Sanford Porter and Nancy Aretta Warriner. Baptized in Jackson Co., Missouri, June 15, 1832. Ordained elder, Oct. 6, 1841. Appointed mission to eastern states, fall 1841. Campaigned for Joseph Smith for president of the US, June 1844. Migrated to the Great Salt Lake Valley in Charles C. Rich company, arriving Oct. 2, 1847. Married Rebecca Ann Cherry, Nov. 12, 1848. Departed on mission to Gibraltar,

Oct. 13, 1852; arrived Apr. 1853 but was soon deported. Continued mission in England. President of the Worcestershire conference of British Isles mission, 1855. Migrated to Great Salt Lake Valley in William B. Hodgetts company, arriving Dec. 10, 1856. Participated in plural marriage. Acting superintendent of Centerville, Davis Co., Utah, Sabbath Schools. Mission to eastern states, 1869, 1872. Counselor to Bishop William R. Smith in Centerville. On Davis stake high council, June 17, 1877. Ordained a patriarch, June 1894. Died in Centerville, Apr. 9, 1897.

Pratt, Orson (1811-81). Born Sept. 19, 1811, in Hartford, Washington Co., New York; son of Jared Pratt and Charity Dickinson. Baptized Sept. 19, 1830. Ordained elder, 1830, and called on mission. Ordained high priest and proselytized in eastern United States, beginning Feb. 2, 1832. Member of Camp of Israel. Ordained member of the Quorum of the Twelve Apostles, Mar. 6, 1835. Married Sarah Marinda Bates, July 4, 1836. Participated in plural marriage. Served a series of short missions, traveling hundreds of miles. Served a mission with other apostles to the British Isles, 1839–41; dedicated Scotland for missionary work. Migrated to Great Salt Lake Valley in Brigham Young company, arriving July 21, 1847. Appointed president over all branches in England, Scotland, Wales, Ireland, and adjacent countries, 1848 and 1856. Migrated with family to Great Salt Lake Valley in James W. Cummings company, Sept. 30–Oct. 30, 1851. Editor of Millennial Star, 1850 and 1856-57. Served mission to Austria, 1865. Published mathematical work, New and Easy Method of Solutions of the Cubic and Biquadratic Equations, 1866. Went to New York in Apr. 1869 to publish Book of Mormon in the Deseret Alphabet. Appointed Church Historian, Jan. 1874. Speaker of Utah House of Representatives, 1874. Served mission to Europe to publish new edition of Book of Mormon, 1878. Died in Salt Lake City, Utah, Oct. 3, 1881.

Redfield, Harlow (1801-66). Born Sept. 25, 1801, in Killingworth, Middlesex Co., Connecticut; son of Levi Redfield and Wealthy Stevens. Married Caroline Foster in present-day Madison, New Haven Co., Connecticut, Dec. 23, 1824; she died, 1834. Baptized Dec. 1831. Married Alpha Luranda Foster in Killingworth, Oct. 11, 1835. Appointed member of high council at Kirtland, Geauga Co., Ohio, Sept. 1837. Ordained a

high priest in Nauvoo, Hancock Co., Illinois, Apr. 8, 1841. Migrated with Aaron Johnson company to the Great Salt Lake Valley, arriving Sept. 12, 1850. Appointed counselor to Bishop Elias Blackburn in Provo, Utah Co., Utah, Mar. 19, 1851. Elected an alderman of Provo, Apr. 1851. Appointed member of high council in Utah Co., 1852. Appointed to serve mission to Siam, 1852, but did not serve. Died Aug. 3, 1866, in Salt Lake City.

Richardson, Darwin Charles (1812–60). Born on June 29, 1812, in Denmark, Oxford Co., Maine; son of Bernice Richardson and Olive Harnden. Baptized by Stephen Burnett, Sept. 1833. Participated in Camp of Israel, 1834. Appointed to first quorum of the seventy, Feb. 1835. Married Jane Cyrene Cobleigh in Lisbon, Grafton Co., New Hampshire, Sept. 2, 1839. Participated in plural marriage. Migrated to Great Salt Lake Valley in Daniel Spencer/Perrigrine Sessions company, arriving by Sept. 25, 1847. Appointed to serve mission to West Indies, by Aug. 29, 1852. Led Darwin Richardson company to Great Salt Lake Valley, arriving Sept. 30, 1854. Died on Nov. 13, 1860, in Salt Lake City.

Riser, George Christian (1818–92). Born July 16, 1818, in Wertemburgh, Germany; son of Christopher Riser and Barbary Hoofman. Immigrated to Ohio in 1831. Married Christiana Kull in Marion Co., Ohio, Jan 10, 1841. Baptized in Nauvoo, Hancock Co., Illinois, Dec. 12, 1842. Practiced plural marriage. Ordained a seventy, 1844. Served mission to Ohio, 1844. Migrated to Great Salt Lake Valley in Abraham O. Smoot company, arriving Sept. 29, 1847. Served mission to Europe, 1853–55. President of German Mission, 1854–55. First counselor to Bishop F. Kesler, 1856. Died in Salt Lake City, Utah, Jan. 24, 1892.

Riter, Levi Evans (1805–77). Born Jan. 1, 1805, in Uwchlan Township, Chester Co., Pennsylvania; son of Michael Riter and Elizabeth Neide. Married Rebecca Woolerton Dilworth, Nov. 24, 1830. Participated in plural marriage. Baptized by Jan. 1, 1845. Ordained a bishop of the First Ward, Winter Quarters, Oct. 1846. Migrated with Jedediah M. Grant/Joseph B. Noble company, arriving in Salt Lake Valley, Oct. 2, 1847. Ordained a high priest, Apr. 6, 1852. Served mission to England, 1852–53. Served mission as colonist in Carson Valley, Utah (later Nevada), May 7, 1856.

Served as counselor to Bishop Samuel A. Woolley. Died in Salt Lake City, Apr. 13, 1877.

Robinson, John (1792–1878). Born Dec. 27, 1792, in Cushing, Lincoln Co., Maine; son of Simon Robinson and Hannah Hyler (Hiller). Married Abigail Parsons in Cushing, July 9, 1814. Captain of ship, *Milo*, near Cushing. Baptized in Maine, by Apr. 17, 1844. Migrated to Nauvoo, Hancock Co., Illinois, before Aug. 22, 1844. Ordained a seventy, before Jan. 20, 1846. Migrated to Utah with the Edward Hunter/Joseph Horne company, arriving Sept. 29, 1847. Ordained bishop of the West Jordan Ward in the Salt Lake Valley, Jan. 20, 1852. Served mission in Nova Scotia and British provinces, ca. 1852–53. Moved to Weber Co., Utah, before Sept. 5, 1857. Wife died, Nov. 1, 1857. Died in Burch Creek (later South Ogden), Weber Co., Utah, Feb. 16, 1878; buried in Uintah, Weber Co., Utah.

Savage, Levi, Jr. (1820–1910). Born Mar. 23, 1820, in Greenfield, Huron Co., Ohio; son of Levi Savage and Polly Hayes. Baptized June 12, 1846. Private in the Mormon Battalion, 1846–47. Migrated to Great Salt Lake Valley in Levi Hancock company, arriving Oct. 16, 1847. Married Jane Mathers, in Utah, Jan. 23, 1848. Ordained a seventy, Oct. 19, 1848. Wife died, Salt Lake City, Dec. 28, 1851. Served mission to Siam, 1852–53, and Burma, 1853–56. Part of the Willie handcart company. Married to Ann Brummel Cooper, Oct. 31, 1858. Died Dec. 13, 1910, in Toquerville, Washington Co., Utah.

Secrist, Jacob Foutz (1818–55). Born Sept. 19, 1818, in Quincy, Franklin Co., Pennsylvania; son of Solomon Secrist and Mary Foutz. Married Ann Eliza Logan in Waynesboro, Franklin Co., Pennsylvania, Mar. 15, 1842. Baptized June 1, 1844. Migrated to Salt Lake Valley with Edward Hunter/Jacob Foutz company, arriving Oct. 1, 1847. Served mission to Germany, 1852–55. Died on the Little Blue River, Kansas Territory, July 2, 1855.

Sessions, Perrigrine (1814–93). Born June 15, 1814, in Newry, Oxford Co., Maine; son of David Sessions and Patty Bartlett. Married Julia Ann Killgore in Newry, Sept. 21, 1834. Participated in plural marriage.

Baptized Sept. 17, 1833. Served missions to Maine, 1839–40, 1841–44, 1873–75. Migrated to the Great Salt Lake Valley in Daniel Spencer/Perrigrine Sessions company, as captain of fifty, arriving Sept. 24–25, 1847. Served mission to England, 1852–54. Captain of Perrigrine Sessions pioneer company, 1854. Died June 3, 1893, in Bountiful, Davis Co., Utah.

Skelton, Robert Hodgson (1824–95). Born Nov. 28, 1824, in Burgh, England; son of Thomas Skelton and Mary Hodgson. Emigrated from Liverpool, England, to New Orleans, Louisiana, in Oct. 1848, on the *Lord Maidstone*. Baptized Mar. 1849. Migrated to the Great Salt Lake Valley in Ezra Taft Benson company, arriving Oct. 25–29, 1849. Served in Nauvoo Legion of Utah during the Walker War, 1850. Ordained a seventy, Feb. 3, 1851. Helped settle Tooele, Tooele Co., Utah. Served mission to India, 1852–56. Presided over East India mission, 1855–56. Married Angeline Gollaher, Feb. 16, 1857. Practiced plural marriage. Served as mayor of Tooele and as a member of the Utah legislature, 1856–57. Served as counselor in Tooele bishopric. Died Feb. 1, 1895, in Tooele.

Smith, Charles (1819–1905). Born July 10, 1819, in Ipstones, Staffordshire, England; son of John Smith and Ann Varley. Baptized Dec. 13, 1840. Appointed to preach the gospel in England, 1841–42. Married Sarah Price, Jan. 3, 1842, in Liverpool, England. Practiced plural marriage. Immigrated to New Orleans, Louisiana, aboard the ship *Swanton*, arrived Mar. 16, 1843. Private in the Nauvoo Legion. Migrated to the Salt Lake Valley with the Heber C. Kimball company, arriving Sept. 24, 1848. Served a mission to England, where he was appointed to take charge of the Derbyshire, Leicestershire, and Nottinghamshire conferences, 1852–55. Moved to St. George, Utah, Apr. 6, 1862. Ordained patriarch of the St. George stake, Mar. 16, 1903. Died Nov. 28, 1905, in St. George.

Smith, Leonard Ishmael (1823–77). Born Mar. 10, 1823, in Hamilton Co., Illinois; son of Randolph Smith and Ann Henson. Baptized May 1, 1847. Ordained to the 14th quorum of the seventy, June 14, 1848. Married Ann King Shanks, Feb. 10, 1852. Participated in plural marriage. Migrated to the Great Salt Lake Valley in 1851. Served mission to the Cape of Good Hope, South Africa, 1852–56. Counselor in South African mission

presidency, May 23, 1853. Appointed president of the 41st quorum of the seventy, Mar. 2, 1857. Carried the mail from Salt Lake City south as far as Fillmore, Utah. Murdered by his nephew in Batesville, Tooele Co., Utah, July 19, 1877; buried in Salt Lake City.

Smith, Paul (1820–1912). Born Apr. 28, 1820, in Great Kelk, Yorkshire, England; son of Paul Smith and Maria Greenwood. Married Jane Wharram, in Howden, Yorkshire, England, 1841. Participated in plural marriage. Baptized Dec. 31, 1848. Immigrated to the US on the *Silverpool*, Mar. 2, 1850. Migrated to Great Salt Lake Valley in James W. Cummings company, arriving Oct. 7, 1851. Served mission to Australia, 1852–55. President of the Snowflake, Navajo Co., Arizona, stake high priests quorum, 1880. Served in the St. George Temple. Ordained a patriarch, 1892. Died July 23, 1912, in Snowflake.

Snider, Egerton (1826–67). Born Jan. 9, 1826, in Toronto, Ontario, Canada; son of John Snider and Mary Herron (Herrin). Baptized by 1842. Moved to Nauvoo, Hancock Co., Illinois, by 1842. Moved to Utah by 1848. Served in Utah territorial militia in William McBride company in Sept. 1850. Married Mary Jane McBride in Utah, Oct. 15, 1850. Served mission to the Sandwich Islands, 1852–55. Died Jan. 7, 1867, in Salt Lake City.

Spencer, Daniel (1794–1868). Born July 20, 1794, in West Stockbridge, Berkshire Co., Massachusetts; son of Daniel Spencer and Chloe Wilson. Married Sophronia Eliza Pomeroy in West Stockbridge, Jan. 21, 1823. Participated in plural marriage. Baptized Mar. 3, 1840. Presided over Richmond and West Stockbridge Union Branch, 1841. Served missions to Canada, Indian Territory, and Massachusetts, 1842–44. Elected member of Nauvoo City Council, Hancock Co., Illinois, by 1843. Elected mayor of Nauvoo, 1844. Ordained a high priest in Nauvoo, Oct. 6, 1844. Served as bishop of Ninth Ward at Winter Quarters (later in Omaha, Douglas Co., Nebraska). Led Daniel Spencer/Perrigrine Sessions company to Great Salt Lake Valley, arriving Sept. 23, 1847. Served as president of Salt Lake stake, 1849–52, 1856–68. Appointed member and treasurer of Perpetual Emigrating Fund Company by Sept. 27, 1850. Began service as member of

Utah territorial legislature, 1851, and as part of Utah territorial legislature council, 1861. Served mission to England, 1852–56. Died in Salt Lake City, Dec. 8, 1868.

Spencer, Orson (1802-55). Born May 13, 1802, in West Stockbridge, Berkshire Co., Massachusetts; son of Daniel Spencer and Chloe Wilson. Served as a Baptist pastor, 1829–41. Married Catharine Curtis, Apr. 13, 1830. Baptized May 1841. Served mission to Connecticut, 1843. Ordained a high priest in Nauvoo, Hancock Co., Illinois, Oct. 6, 1844. Elected mayor of Nauvoo, Feb. 3, 1845. Wife died near Keosauqua, Van Buren Co., Iowa Territory, Mar. 12, 1846. Served mission to England, 1846–49; presided over British Mission, 1847-49. Married Martha Knight of Lancaster, Lancashire Co., England, Apr. 1847. Participated in plural marriage. Led the Samuel Gully/Orson Spencer company to the Great Salt Lake Valley, arriving Sept. 23, 1849. Appointed chancellor of the University of Deseret, Feb. 28, 1850. Member of the Utah territorial legislature, 1851. Served mission to Prussia, England, and Germany, 1852–53. Served mission to Cincinnati and St. Louis, 1854-55; editor of the St. Louis Luminary; president of the church in the Ohio and Mississippi Valleys. Died in St. Louis, Oct. 15, 1855. Final burial in Salt Lake City.

Stevenson, Edward (1820–97). Born May 1, 1820, in Gibraltar, British Overseas Territory; son of Joseph Stevenson and Elizabeth Stevens. Emigrated from Gibraltar to US on ship *Canning*, arriving in New York July 16, 1827. Baptized by Japhet Fosdick at Silver Lake, Michigan, Dec. 20, 1833. Married Nancy Areta Porter in Nauvoo, Hancock Co., Illinois, Apr. 7, 1845. Participated in plural marriage. Ordained a seventy by Joseph Young, Feb. 7, 1845. Migrated with Charles C. Rich company to Great Salt Lake Valley, arriving Oct. 2, 1847. Appointed to serve mission to Gibraltar, Aug. 28, 1852. Served missions in United States and Canada, 1857–58, 1869–70, 1872, 1877–78, 1883–84. Divorced Nancy Areta Porter in Salt Lake City, July 3, 1869. Set apart for mission to US and Europe, Feb. 1886. Crossed Atlantic Ocean nine times and Great Plains eighteen times as missionary. Selected as one of the first seven presidents of the seventy, Oct. 7, 1894. Died Jan. 27, 1897, in Salt Lake City.

Stout, Hosea (1810-89). Born Sept. 18, 1810, in Mercer Co., Kentucky; son of Joseph Stout and Anna Smith. Married Samantha Peck, Jan. 7, 1838. Baptized in Caldwell Co., Missouri, Aug. 24, 1838. Wife died, Nov. 29, 1839. Appointed clerk of high council in Nauvoo, Hancock Co., Illinois, Mar. 8, 1840. Married Louisa Taylor, Nov. 29, 1840. Participated in plural marriage. Elected colonel of fifth regiment, second cohort in Nauvoo Legion, June 23, 1843. Selected as chief of police in Nauvoo, by Oct. 1844. Ordained an elder, Oct. 4, 1844. Ordained a president of 11th quorum of the seventy, Oct. 8, 1844. Migrated with Brigham Young company to Great Salt Lake Valley, arriving Sept. 23, 1848. Appointed attorney general of the provisional state of Deseret, by Mar. 1850. Served mission to China, 1852-53; wife and infant son died, Jan. 1853. Elected speaker of House of Representatives in Utah territorial legislature, Dec. 1856. Appointed to settle southern Utah, Oct. 8, 1861. Appointed foreman of St. George high council, Washington Co., Utah, May 1864. Appointed to Salt Lake stake high council, 1870. Died on Mar. 2, 1889, in Big Cottonwood, Salt Lake Co., Utah.

Tanner, Nathan (1815–1910). Born May 14, 1815, in Greenwich, Washington Co., New York; son of John Tanner and Lydia Stewart. Baptized Sept. 1832. Member of Camp of Israel, 1834. Married Rachel Winter Smith, in Bolton, New York, June 1836. Appointed as a president of fourth quorum of the seventy, Oct. 8, 1844. Migrated to the Great Salt Lake Valley with the Willard Richards company, arriving Oct. 10, 1848. Served mission to the Sandwich Islands, 1852. Freighted between Salt Lake and Los Angeles, California. Died Dec. 17, 1910, in Granger, Salt Lake Co., Utah.

Taylor, William (1823–1910). Born Sept. 2, 1823, in Hale, Westmorland, England; son of James Taylor and Agnes Taylor. Baptized Mar. 2, 1841. Ordained a seventy on Feb. 26, 1845. Married Lovina Chandler by June 1847. Participated in plural marriage. Migrated to the Great Salt Lake Valley in Edward Hunter/Joseph Horne pioneer company, arriving Sept. 29, 1847. Served mission to Germany, 1852. Member of the French

Mission presidency, 1854. Located in the Big Cottonwood Ward, Salt Lake Co., Utah, 1862. Died in Holladay, Salt Lake Co., 1910.

Thomas, Elijah (1815–1906). Born Jan. 22, 1815, in West Rockingham, Richmond Co., North Carolina; son of Henry Thomas and Esther Covington. Baptized Feb. 14, 1844. Ordained a seventy, Nov. 1844. Member of the Mormon Battalion, 1846–47. Married Mercy Murray Day in San Francisco, California, 1848. Participated in plural marriage. Migrated to the Salt Lake Valley in the Ebenezer Brown company, arriving Oct. 10, 1848. Served a mission to British Guiana. Returned to the Salt Lake Valley in the David H. Cannon company, arriving by Aug. 16, 1861. Living in St. George, Washington Co., Utah, by June 1870. Living in Leeds, Washington Co., Utah, in June 1900. Died Oct. 14, 1906, in St. George.

Thomas, Preston (1814–77). Born Feb. 15, 1814, in Rockingham, Richmond Co., North Carolina; son of Daniel Thomas Jr. and Nancy Ann Morehead. Married Sarah Ann Jane Morehead in Tennessee, May 10, 1838. Participated in plural marriage. Baptized Jan. 13, 1844. Served mission to southern states, 1847–48. Served mission to Texas, Nov. 1848–July 1849; Nov. 1849–50. Migrated to the Great Salt Lake Valley in John Brown company, arriving Sept. 29, 1851. Again served mission to Texas, 1852. Led subsequent companies arriving in the Great Salt Lake Valley, Nov. 1853 and Sept. 1856. Served mission to Texas, 1854–56. Served as adjutant in Nauvoo Legion of Utah, 1857. Served mission to southern states, 1869–56. Died July 10, 1877, near Franklin, Franklin Co., Idaho.

Thomson, Walter (1825–77). Born Aug. 10, 1825, in Barony, Glasgow, Scotland; son of John Thomson and Margaret Thomson. Baptized Jan. 4, 1841. Married Agnes Ross in Rowe, Dunbarton, Scotland, Nov. 13, 1847. Served as clerk of Glasgow conference, 1849–50. Emigrated with wife and two children from Liverpool, England, arriving in New Orleans, Louisiana, Mar. 20, 1851. Migrated to the Great Salt Lake Valley in Morris Phelps company, arriving Sept. 26–Oct. 1, 1851. Ordained a seventy, Feb. 22, 1852. Called on mission to China, but fell ill and stayed in California, 1852–53. Served as Weber Co., Utah, recorder, 1869. Died June 13, 1877, in Ogden, Weber Co.

Thurston, Moses (1817–73). Born Sept. 13, 1817, in present-day Belmont, Waldo Co., Maine; son of John Thurston and Rebecca French. Baptized by William Anderson in Bureau Co., Illinois, June 2, 1842. Ordained an elder, Sept. 1842. Appointed to 26th quorum of the seventy, Apr. 9, 1845. Married Lucy Jane Leonard in Winter Quarters, Nebraska, ca. 1846. Migrated to Great Salt Lake Valley in Jedediah M. Grant/Willard Snow company, arriving Oct. 4, 1847. Traveled to unorganized US territory (later in California) in William D. Huntington company to mine gold, May 7, 1850. Appointed to serve mission to Europe, Oct. 13, 1852. Led Moses Thurston company from Mormon Grove, Atchison Co., Kansas, to Great Salt Lake Valley, arriving Sept. 19, 1855. Served mission to Muddy Valley, 1868. Held office in militia. Died on Aug. 5, 1873, in Salt Lake City.

Toner, Daniel (1800–1881). Born Feb. 1, 1800, in Letterkenny, Ireland; son of James Toner and Catherine O'Donell. Married Biddy Donell. Lived in Montgomery and Grimes counties, Texas, 1845–50. Baptized Apr. 1849. Called to serve mission to Ireland, Aug. 28–29, 1852. Arrived in England, Apr. 1, 1853. Migrated to the Great Salt Lake Valley in Jacob Croft company, arriving Oct. 11, 1856. Migrated to Spanish Fork, Utah Co., Utah, by Aug. 24, 1860. Married Anne Mary Peterson by Aug. 4, 1870. Died May 12, 1881, in Spanish Fork.

Treat, Thomas Wight (1803–70). Born Apr. 3, 1803, in Schuyler, Herkimer Co., New York; son of Charles and Amy Treat. Married Mary M. Lawyer in Nauvoo, Hancock Co., Illinois, Dec. 8, 1842. Enlisted in Mormon Battalion in Miller's Hollow (later Council Bluffs), Iowa Territory, July 16, 1846; discharged in present-day Los Angeles, California, July 16, 1847. Wife died, by 1849. Migrated to Great Salt Lake Valley in Thomas Rhoades company, arriving Sept. 1849. Appointed to serve mission to England by Aug. 29, 1852. Arrived in England on ship *American Union*, Jan. 5, 1853. Departed from England on ship *Jersey*, June 29, 1853. Migrated to Great Salt Lake Valley in Canute Peterson company, arriving by Sept. 23, 1856. Married Caroline Elizabeth Dyer Winter in Marriott-Slaterville, Weber Co., Utah, Mar. 14, 1863. Died on Dec. 8, 1870, in Ogden, Weber Co.

Turpin, Jesse (1816–54). Born June 22, 1816, in Panther Creek, Stewart Co., Tennessee; son of James Turpin and Nancy Ann Tatum. Baptized Apr. 14, 1836. Served mission to Virginia, Apr. 24, 1837. Ordained a seventy, Apr. 14, 1840. Served mission to eastern states, 1840. Married Eliza Ann Boggess, Dec. 24, 1840. Served mission to his family in Kentucky, winter 1844–45. Married Jane Louisa Smith, Apr. 16, 1846. Participated in plural marriage. Migrated to the Great Salt Lake Valley in Brigham Young company, arriving Sept. 20, 1848. Served mission to West Indies, Oct. 13, 1852. Left West Indies and continued mission in the middle states, Feb. 1853. Died June 22, 1854, while returning from mission, near Fort Leavenworth, Kansas.

Van Cott, John (1814–83). Born Sept. 7, 1814, in Canaan, Columbia Co., New York; son of Losee Van Cott and Lavina Pratt. Baptized Sept. 1845. Married Lucy Levinia Sackett, by June 15, 1847. Participated in plural marriage. Ordained a seventy, Feb. 25, 1847. Migrated to the Great Salt Lake Valley in Daniel Spencer/Perrigrine Sessions company, arriving Sept. 23 or 24, 1847. Served mission to England, Oct. 13, 1852. Presided over British Mission, Sept. 1853. President of the 41st quorum of the seventy, 1857. President of the Scandinavian Mission, Sept. 16, 1859. Served as a member of the Utah House of Representatives, 1864–65. Died Feb. 18, 1883, in Salt Lake City.

Walker, William Holmes (1820–1908). Born Aug. 28, 1820, in Peacham, Caledonia Co., Vermont; son of John Walker and Lydia Holmes. Baptized 1835. Married Olive Hovey Farr in Nauvoo, Illinois, Nov. 1, 1843. Participated in plural marriage. Ordained member of the 13th quorum of the seventy, Aug. 1844. Enlisted in the Mormon Battalion, July 16, 1846. Migrated to the Great Salt Lake Valley in the Mormon Battalion sick detachments and the Spencer-Eldredge company, arriving Sept. 1847. Served mission to Cape of Good Hope, South Africa, 1852–57. Appointed to a mission to southern Utah, 1861. Ordained a high priest and patriarch, May 20, 1892. Died Jan. 9, 1908, in Lewisville, Fremont Co., Idaho.

Webb, Chauncey Griswold (1811–1903). Born Oct. 24, 1811, in Hanover, Chautauqua Co., New York; son of James Webb and Hannah Griswold. Baptized in New York, Nov. 27, 1834. Ordained a seventy at Kirtland, Ohio, Feb. 28, 1835. Married Eliza Jane Churchill in Kirtland, Sept. 15, 1835. Participated in plural marriage. Appointed one of the presidents of 25th quorum of the seventy in Nauvoo, Hancock Co., Illinois, Oct. 24, 1845. Built wagons and later handcarts for church members migrating to Utah, including wagon used by Brigham Young. Migrated to the Great Salt Lake Valley with the Brigham Young company, arriving Sept. 1848. Served a mission to England, 1852–55. Assigned by Brigham Young to go to Chicago, Cook Co., Illinois, to build sixty wagons and carriages for the YX Company, Apr. 21, 1857. Died Apr. 7, 1903, in Salt Lake City.

West, Chauncey Walker (1827–70). Born Feb. 6, 1827, in Erie Co., Pennsylvania; son of Alva West and Sally Benedict. Married Mary Hoagland in Nauvoo, Hancock Co., Illinois, May 1, 1846. Participated in plural marriage. Migrated to Great Salt Lake Valley in Edward Hunter/Joseph Horne company, arriving Sept. 29, 1847. Served mission to Asia, 1852–54. Served as presiding bishop of Weber Co., Utah, by May 29, 1856. Served in Utah house of representatives, 1856–62, 1864–69. Died Jan. 9, 1870, in San Francisco Co., California.

Willie, James Grey (1814–95). Born Nov. 1, 1814, in Murrell Green, Southampton, England; son of William Willie and Mary Sutton. Baptized July 12, 1842. Married Elizabeth Ann Pettit in Nauvoo, Hancock Co., Illinois, June 13, 1846. Participated in plural marriage. Migrated to the Great Salt Lake Valley in Jedediah M. Grant/Joseph B. Noble company, arriving Oct. 2, 1847. Served a mission to England, 1852–56. Captain of the James G. Willie handcart company that arrived in the Salt Lake Valley, Nov. 9, 1856. Served as bishop of Salt Lake Seventh Ward, 1856–59. Called by Brigham Young to help settle Cache Valley in northern Utah. Settled in Mendon, Utah, 1867. Member of bishopric in Mendon, 1884–90. Served as a patriarch, 1892–93. Died Sept. 9, 1895, in Mendon.

Woodward, William (1833-1908). Born Jan. 4, 1833, in Bushey, Hertfordshire Co., England; son of William Field and Sophia Woodward. Baptized in Watford, Hertfordshire Co., June 21, 1848. Emigrated from Liverpool, England, to Kanesville (later Council Bluffs), Iowa, arriving Apr. 9, 1850. Migrated to Great Salt Lake Valley as a teamster in the John Reese freight train, 1851. Appointed to serve mission to England, Aug. 29, 1852; returned in James G. Willie company, 1856. Married Harriet Hogan in Great Salt Lake City, Feb. 1, 1857. Participated in plural marriage. Migrated to present-day Franklin, Franklin Co., Idaho, Apr. 14, 1860. Appointed justice of the peace of Franklin, by Dec. 28, 1868. Served missions to England, 1873, 1904. Appointed president of the 18th quorum of the seventy, Dec. 29, 1874. Ordained a high priest, Feb. 1901. Died on Nov. 22, 1908, in Franklin.

Woolley, Samuel Amos (1825–1900). Born Sept. 11, 1825, in Newlin, Chester Co., Pennsylvania; son of John Woolley and Rachael Dilworth. Baptized Oct. 7, 1840. Married Catherine Elizabeth Mehring, May 21, 1846. Participated in plural marriage. Migrated with Brigham Young company to the Great Salt Lake Valley, arriving Sept. 21, 1848. Ordained a seventy, Oct. 8, 1845. Served mission to India, 1852–56; to eastern US (Ohio, Pennsylvania, Kentucky, and Michigan), 1869–70. Appointed bishop of the Salt Lake Ninth Ward, 1865. Ordained a patriarch. Died on Mar. 23, 1900, in Salt Lake City.
